The School Boards of the Lamphere Schools and the Troy School District, are requesting sealed bids for bread and related items for the **fiscal year 2008-09**, according to the following specifications and provisions:

1. All bid proposals must be submitted on the bid form provided, two have been enclosed for your convenience. The envelope must be clearly marked "**Bread Bid**". Quotations must be the exact net price per unit including all discounts, (carry to three decimals).
2. All bids must be received at the Troy School District Purchasing Office, 1140 Rankin, Troy, MI 48083, on or before **Tuesday, August 12, 2008 by 3:00 p.m.**
3. Bid prices must be firm for 90 days. The school district must be notified in writing 30 days prior to any change in price.
4. If at any time during the school year the low bidder is unable to meet the service as required by the school district, the school district reserves the right to cancel the bid award.
5. All deliveries must be made before 9:30 a.m. to all schools. The individual schools and addresses are attached.
6. All monthly billing statements must be received in the Food Service Office of the respective districts. Monthly cut-off dates will be supplied prior to school opening to the successful bidder.
7. The Board of Education reserves the rights to accept or reject any or all bids, to waive informalities and to accept the bid, which will best serve the interest of the school district.
8. Michigan allows for use of USDA Commodity flour in school-baked products with approved NCP Contract. Prices are solicited with and without the use of USDA Flour. The NCP Identification Number for Troy School District is 126020377.

The breads must be made with enriched flour and contain no preservatives, each serving to weigh no less than one (1) ounce.
