## **REMINDER**

2019-20 Child Development Center Information (Before and After School Care)

January 10, 2019

Dear Prospective Parents/Guardians:

The Wiseburn Unified School District operates Child Development Centers that provide "Before and After-School" Programs for school aged students grades Kindergarten – 5<sup>th</sup> grade, and preschool programs for children ages 3-5. A web- based student application system (https://wiseburn.schoolmint.net) has been developed to assist with enrollment, district-wide tracking of open seats and wait list priorities. The Wiseburn community has growing needs for Kindergarten – 5<sup>th</sup> grade before and after school child care, as well as a preschool program for children ages 3-5. As a result, application and enrollment priorities have been identified to address these needs. For the 2019-20 school year, admission priorities will be as follows:

- 1) Families of students currently enrolled in the Before and After School program, and their incoming siblings, will be given a priority window of February 1, 2019-February 22, 2019 to re-register for the "Before and After-School" Program at their site for the 2019-20 school year.
- 2) Families of students currently on the waitlist will be given a priority window of February 25-March 1, 2019 to indicate their intent to remain on the waitlist for a 2019-20 placement in the Before and After-School" Program at their site. Communication will be sent to all waitlisted families, and they will be required to indicate their intent to remain on the waitlist within the priority window.
- 3) Wiseburn residents new to the program will be given a priority application window of March 4, 2019 March 22, 2019.
- 4) **Open enrollment for other interested families** will begin on <u>April 1, 2019</u> and will be ongoing. Students entering into the district due to an inter-district permit can apply and will be considered once the permit has been granted and openings are available.
- 5) Parents with students currently enrolled in the CDC Preschool Program who will transition to kindergarten, will need to access the application process based on the above stated admission priority windows. Enrollment in the Wiseburn CDC Preschool program does not automatically secure a space in the Kindergarten Before or After-school program.

Although the Wiseburn USD CDC program is not a required district program and is a separate fee based parent funded program offered on the Wiseburn campuses, the district has responded to the community need and is doing its best to accommodate as many students it can. Mark your calendars to ensure that you are accessing the web-based portal (<a href="https://wiseburn.schoolmint.net">https://wiseburn.schoolmint.net</a>) during these important enrollment windows.

If you need access to a computer to complete your application on-line, one will be made available for you to use at the Anza, Cabrillo or Burnett CDC sites.
