# AMENDMENT AGREEMENT DATED AUGUST 9, 2017, TO EMPLOYMENT AGREEMENT OF THE SUPERINTENDENT DATED JUNE 15, 2016

BY AND BETWEEN THE BOARD OF EDUCATION OF THE HARRISON CENTRAL SCHOOL DISTRICT (hereinafter the "Board") and DR. LOUIS N. WOOL (hereinafter the "Superintendent");

WHEREBY, the parties agree to amend the provisions of the Superintendent's Employment Agreement dated June 15, 2016, as follows:

1. Article III(2)(B) - Vacation - is hereby amended to entitle the Superintendent to receive compensation for an additional nine (9) unused vacation days to those previously referenced as compensable and that were vested for use during the 2016-17 school year, at the per diem rate specified in this provision of the Superintendent's Employment Agreement.
