Under Redistricting Overview, Assistant Superintendent of Operations Eddie Anderson presented the Guiding Principles, Redistricting Timeline and the top three comments from the public.

Redistricting  
Overview

Mr. Anderson proposed to keep study areas 202 and 203 in the New Hanover High School district, to maintain the existing Hoggard satellite and consider options to expand the Hoggard district to increase enrollment. Mr. Anderson stated that the proposed plan would have minimal impact on Free and Reduce numbers at New Hanover High School. He also shared that the Sheriff's Gang Taskforce confirms the high school redistricting proposal will not create problems with rival gangs at any of our schools.

Proposal

Two maps will be forthcoming – one will implement the above recommendations and the second will look at moving Landfall residence to New Hanover High School.

- Angela Davis lives 2.5 miles from Hoggard. Her district is NHHS, which is 3.6 miles away. The proposed map has her going to Ashley. The distance to Ashley is 8.6 miles, which is too far.
- Dr. John Creasy's daughter is 14 and she currently attends Laney High School. The family lives in Covil Farms. The proposed map places the student at NHHS. The family wishes to stay at Laney. Dr. Creasy would like the Board to remember that the students are not dots on the map; they are children.

- Gina Fimble would like to see equitable distribution. She believes NHHS is carrying a heavier burden than the other three traditional high schools. She also stated that Freeman Elementary School is 85 % black and Hispanic. The school has a 71 % suspension rate.
- Marrio Jeter is with Community in Schools. The original proposal caused concerns, but after seeing the proposed revisions those concerns have been addressed.
- Charles Baldwin lives on Princeton Drive. He has two NHHS students. They are in the 203 study area. He thanked the Board for considering public input. He stated that his school community is committed to NHHS. They are active and involved. He stated that other neighborhoods are also committed to their neighborhood school. He asked that the Board not to split-up neighborhoods; to divide along main roads; and ensure diversity in all schools. He asked that Open Enrollment be able to continue.
- Linda McCourtie is from the Kings Grant community. She is concerned that her child will now be districted for NHHS instead of Laney.
- Carla Knob has a 9<sup>th</sup> grader at NHHS who is not currently in a specialty program. The student is planning to participate in the Lyceum Program in the 11<sup>th</sup> and 12<sup>th</sup> grades. She is not sure if her student will be able to stay at NHHS. The proposal is scaring people away from the school. She asked that the Board send a message that Open Choice is still alive and well.
- John Skelton is an Ashley High School student. He would like the choice to stay at the school where he started his high school career. He would like other students to have the same opportunity, and he asked that the Board treat students as people not numbers.
- Hamilton Hicks endorses staff's recommendations for NHHS.
- Amie Lombardi lives in Covil Estates. She asked why a small part of her neighborhood was impacted by the current map instead of looking at the Landfall area. She would like her student to continue at Laney.
- William Condon has a student at Ashley High School. The proposal puts her at Hoggard. She is involved in the Nursing Program at Ashley. He supports her staying at Ashley.

- Deirdre Condon moved from New York. Ashley is the best fit for her family. She has bought a house in the Ashley district and would like to stay there. She shared this is the worst time to move the 9% of students. She would like to see all currently enrolled student be allowed to stay at his or her school. The current proposal will have her student going to Hoggard.
- Sarah Bailey stated that changing lines effect the students and their families. Other counties are looking at what NHCS is doing because we are leaders. Eyes are on us. Be careful were you draw the lines.
- Lynore Young has concerns regarding the proposed plan. She stated that Mr. McAdams served NHHS well, but this plan fails the current administration, teachers, staff and students. The Board needs to seek a solution that provides better balance without increasing the disadvantage numbers.
- Philip Maginns has a 9<sup>th</sup> grader districted for NHHS. For 25 years, he has planned for his children to attend Ogden, Noble, and Laney. This was always the plan for his children. He bought a home in a location that was conducive to his plan. The Board has jumped over Landfall and pulled from Covil Estate, which he said is not fair.

Board Comments

Board Member Bruce Shell

We started down this path because of overcrowding at Laney High School. Staff generated a plan, a draft that has had strong reaction from the public. Clearly, changes need to be made. Several times someone has said to us look at this objectively. The staff has looked at it objectively. I understand the public better after tonight. The challenge that I see when you try to fix overcrowding is that not all will be pleased. I do think we made some errors. We need to look at improving the maps. All seven Board Members want to come up with a solution to overcrowding. In addition, we believe in neighborhood schools. I encourage the public to continue to provide feedback on all plans.

Board Member Donald Hayes

This is a starting point, and I want to say that I do not support splitting up neighborhoods. The New Hanover County Board of Education does not have taxing authority and is unable to provide its own funding. The school system relies on the County. I appreciate the comments, and the Board will look at the concerns expressed. The Board will honor those attending schools under Open Choice.

Board Vice-Chairwoman Jeannette Nichols




