1.01	Are you currently using a web-based job submission tool like the one requested in Option 3 (RFP 2.06)?	No.
1.02	Is archiving a requested function for the web-based job submission tool requested in Option 3 (RFP 2.06)?	No.
1.03	Please provide the number of software licenses and HID access cards for accurate pricing of Optional Products and Services (RFP 2.06).	Please refer to Addendum 1.01.
1.04	The anticipated volume for copiers listed in RFP 2.03 for Copier 3 seems high. Are these numbers accurate?	These anticipated volumes have been revised. Please refer to Addendum 1.02.
1.05	Do you currently have a plockmatic in use on Copier 3 in RFP 2.03?	Yes, however any brand that meets the minimum specifications in RFP 2.03 will be accepted.
1.06	RFP 2.02 includes a minimum requirement of a warm up time and recovery time from sleep of less than 20 seconds. What if a machine responds at 22 seconds?	RFP 2.02 indicates that "Bidder shall propose products that meet or exceed the following specifications". If you would like to request an exception to this specification, please do so in accordance with RFP 3.04A.
1.07	Do you have any green initiatives that would impact the 20 second warm up time and recovery time from sleep requirement?	No.
1.08	How many of each machine for MFD 1 and MFD 2 should be provided?	Please refer to RFP 2.02.

1.12	I just wanted to submit in writing my request for consideration of accepting an 80PPM color machine for the print center now listed as 85PPM. No other specifications would change. Even if it was a range of 80PPM to 100PPM it would allow greater potential options for the Print Center and more open competition.	Due to the large volume of printing with quick timelines on this machine, the specification in RFP 2.03 for Copier 3 of 85PPM will not be changed.
