# SUPERINTENDENT'S COMMUNICATION

<u>Fall Housing Report</u> – Assistant Superintendent of Finance and Operations Chris Whelton reported on the internal enrollment projections for 2018-2019. Dr. Moyer shared the 2018-2019 class size update.

<u>Change Protocol Document</u> – Dr. Moyer introduced an internal planning document to help guide leaders and staff in outlining their project and decisions. Feedback on the tool will be offered in Summer 2019.

York Final Exam Exemption – Dr. Moyer presented a draft of York High School Administration's effort to extend senior students the opportunity to be exempt from exams in their 8th (Spring) semester prior to graduation. York will finalize the draft based on the Board's feedback and pilot the exemption during second semester upon the addition of a sliding scale.

**FOIA Requests** – Four Freedom of Information Act requests were received:

- Two requesting certain documents related to the Facilities Master Plan; one was granted and one was denied.
- One requesting specific employee information which was granted.
- One requesting specific invoice information which was granted.
