## Key Take Aways

The Unionville Sports Council (“USC”) is a registered Pennsylvania Non Profit Corporation with a mission to encourage and support physical activity throughout the Unionville Chadds Ford School District (“UCFSD”) by engaging in a variety of supportive activities, such as:

- Encouraging increased opportunities for, and participation in, diverse physical activities;
- Cooperating with the UCFSD in promoting the best interests of its athletic programs;
- Fostering a sense of spirit and pride in the UCFSD community;
- Raising funds for special equipment and programs desirable by the community that are not specifically provided for by the UCFSD; and
- Providing an umbrella organization for focused subcommittees (“Boosters”).

### How USC helps Booster Clubs save money:

- HUDL License – USC obtains 1 overall license (at reduced rates) for this video software & online application for athletes, coaches and college recruiting.
- Concession Stand Operations – no need to duplicate the licenses that USC has already obtained.
  - USC supplies the Operator’s License
  - USC supplies the Food Handler’s License
- PA State Tax Exemption – as a 501(c)(3) charitable organization, USC is exempt from Pennsylvania sales tax. USC has a form that you can use to avoid paying sales tax.
- PA State Gaming License – USC has a license that covers many items (i.e. 50/50 raffle).
- USC pays for preparation and filing of all gov’t docs (taxes, PA state registrations, etc.).

### How USC helps Booster Clubs raise money:

- As a 501(c)(3) charitable organization, USC can supply receipts to donors for tax purposes.

### How Boosters can help raise money for themselves and USC:

- United Way – The United Way organizations of Delaware, Southern Chester County, and Greater Philadelphia/Southern NJ have approved USC in their Donor Choice Program. If your employer has an annual United Way Giving Campaign, please consider designating USC as the recipient organization. This way your contributions go to work right in your own school district!
- Affiliate Marketing Program (Click Thru Fee) – Do you shop online? USC can earn a % of your on-line purchases from Amazon without any extra effort or dollar contribution from you. Simply use [smile.amazon.com](http://smile.amazon.com) instead of [www.amazon.com](http://www.amazon.com) and choose the Unionville Sports Council as your beneficiary and complete your shopping as normal.
- Corporate Matching – Does your employer have a matching gifts program? If YES, then USC may qualify to receive a “company match” of your donation.
