Is your BENEFICIARY current?

<u>Do not use</u> "All Living Children" as a beneficiary designation!

Log in to TBX: https://tbx.benselect.com/enroll/login

Login ID – your Employee ID# <u>PIN</u> – the last 4 digits of your SSN# and last 2 digits of birth year

Click on "You & Your Family" menu option (top of screen) Click on "Life Events" Click on "I wish to change the beneficiary of one of more of my benefits." **Click** "Next" button until you get to "Confirm" page to enter your PIN

Does your spouse work for MISD?



If yes ----

- Spouse cannot be a dependent on your Standard supplemental life insurance policy.
- Flexible spending Dependent Care limit (per IRS) is \$5000 per family.
- If your spouse is enrolled in a health savings (H.S.A.) account, you cannot be enrolled in the TaxSaver Healthcare FSA/Unreimbursed Medical account.



The IRS has extended the issue date for form 1095-C to <u>March 4th</u>. Form 1095-C is a tax form that serves as proof to the IRS that you had affordable health insurance available to you throughout the year. The form will be sent (TO YOUR CAMPUS) to employees who are full-time and regularly scheduled to work 30+ hours per week.

You will use this form as part of your tax filing process, just as you use a W-2, 1099 or other tax form. You <u>do not</u> need to submit it with your tax form (1040, 1040A or 1040EZ).

Flexible Spending Account (FSA) New Third Party Administrator New Way of Processing Receipts Not New Rules!

TaxSaver Plan is our new FSA provider. Plan participants will have to provide receipts for services. The receipt requirement is mandated by the IRS. Services must be for *eligible expenses* and *incurred in the plan year* (9/1/18 - 8/31/19). For a list of eligible items, go to www.taxsaverplan.com.
