## Innovative Instructional Opportunities in Northern Mansfield ISD

### August 28, 2018

#### **Purpose**

The purpose of this committee is to make recommendations to be considered for recommendation to the Board of Trustees by Executive Council and Superintendent concerning the facility usage and innovative educational opportunities in Northern Mansfield ISD. This effort goes toward the realization of Guiding Statement #5, which states, "Our parents and students will have choices with educational opportunities."

#### **Responsibilities of the Committee**

The ad hoc committee's work will center on the implementation of Innovative Instructional Opportunities in Northern Mansfield ISD by seeking to answer the following three questions:
