Elmonica, Beaver Acres & McKinley Elementary Boundary Adjustment Decision

This is the report of findings and recommendation by the Elmonica, Beaver Acres & McKinley Boundary Adjustment Advisory Committee, and the Superintendent's review of that recommendation and decision. The Superintendent will present this decision to the School Board for consideration and approval, as per Policy JC.

The Superintendent would like to thank the Boundary Advisory Committee members for their service and for their dedication to this difficult task. They were thoughtful and compassionate in their approach and rendered a recommendation that fully considered all the communities of Elmonica, Beaver Acres and McKinley.

District Goal: WE Empower all students to achieve post-high school success.

#### Introduction

Elmonica's growth in enrollment is linked to the increase in the general population within its current attendance boundary. The increase is attributable, in part, to new residential development. In response to the increased enrollment over the years, the District has installed 13 portable classrooms on site, two of which were added in 2018. Elmonica has a total building capacity of 713 students (466 seats in the permanent building, supplemented by 247 additional seats in portables). The school serves only general education students and does not house a Self-Contained Specialized Program or Pre-Kindergarten program.

During the same period, Beaver Acres and McKinley Elementary Schools, which are adjacent to Elmonica, have experienced a decline in enrollment. As of this school year, both schools are below 75% of their total capacity.

In consultation with Teaching & Learning administrators and the principals of Elmonica, McKinley, and Beaver Acres, Facilities staff concluded that a boundary adjustment is necessary to relieve overcrowding at Elmonica and balance enrollment at Beaver Acres and McKinley. The Superintendent initiated a boundary review process in consultation with the School Board, as per Policy JC in December of 2018.

#### **Process Overview**

As per Policy JC, at the December 17, 2018 meeting of the Beaverton School Board, the Superintendent proposed and the Board approved two objectives for the

Elmonica, Beaver Acres and McKinley Elementary school boundary adjustment process:

The objectives for the Elmonica Boundary Adjustment were:

- Objective 1: Create an attendance boundary amendment that will provide overcrowding relief for Elmonica Elementary School for the SY 2019-20 school year.
- Objective 2: To the degree feasible, balance future enrollment with each affected school's capacity.

The Superintendent appointed an Advisory Committee, made up of six (6) parents from each of the affected schools. The Principals for each affected school served as non-voting members of the Advisory Committee. The Advisory Committee met twice, at Elmonica Elementary School, on Saturday February

2<sup>nd</sup> and Wednesday, March 13<sup>th</sup>, 2019. Both meetings were open to the community and included an opportunity for public input.

The Advisory Committee, with the assistance of District staff, studied alternatives for boundary adjustments to meet the Board-adopted objectives. In their evaluation of the alternatives, the Advisory Committee considered the boundary adjustment factors, as outlined in Policy JC:


- Student body composition;
- Current and future availability of space;
- Feeder patterns to elementary, middle and high schools; and
- Neighborhood proximity and accessibility.

Over the course of the two meetings, the Advisory Committee studied alternatives and considered input from the public and issued a recommendation on a new attendance boundary map to the School District Superintendent.

The committee's recommendation was as follows:

- Move Area A from Elmonica (generally bounded by SW 185<sup>th</sup>, the Willow Creek/Salix Park waterway, and SW Cambray Street) to McKinley Elementary School for the Fall of 2019
- Move Area B from Elmonica (generally bounded by SW 158<sup>th</sup> Avenue, SW Baseline Road, and the Trimet MAX rail line) to Beaver Acres for the Fall of 2019.
- 3) Offer to incoming 5<sup>th</sup> graders, and to not include younger siblings, the option to remain at Elmonica Elementary for the SY 2019-20 school year (the committee voted on a split decision to not recommend the District provide bus transportation to incoming 5<sup>th</sup> graders who elect to remain at Elmonica).

After the Advisory Committee issued its recommendation, District staff sent a letter to all families with students in the



areas proposed for moving to Beaver Acres or to McKinley Elementary Schools informing them of the Committee's recommendation and invited those interested parties to submit comments on the recommended boundary adjustment for the Superintendent's consideration prior to his taking action.

After reviewing the record including written testimony received after the Advisory Committee issued its recommendation, the Superintendent agrees with the Advisory Committee's recommendation and has decided to accept the recommendation without amendment. The Superintendent also agrees with the recommendation of the Advisory Committee that the boundary adjustment will meet the Board objectives. Therefore, the Superintendent recommends the Board acknowledge that the Elmonica Boundary Adjustment satisfies the Board Objectives dated December 17, 2018.


#### **Background Information**

The following section outlines the background information provided to the Advisory Committee regarding, middle school and high school feeder patterns, historic and projected enrollment, and demographic information.


#### **Feeder Patterns**

Each of the three schools is within the Five Oaks Middle school attendance boundary, and each feed to either Westview or Aloha High School.

#### All feed to Five Oaks MS




#### Portions Feed to Westview or Aloha HS




#### **Historic Enrollment & Building Capacity**

Historic enrollment at each of the three schools is shown below. Enrollment at Elmonica has increased steadily since 2015, driven in part by residential development in the area.


Elmonica Building Capacity 466 (permanent building) 247 (13 portable classrooms) 713 total capacity

\*Building capacity refers to the general education population; it does not include space for students in Self Contained Specialized Programs (SCSP). Those spaces and programs are accounted for separately and are not affected by the boundary adjustment process.



#### **Projected Students**

For the purposes of the boundary adjustment process, staff prepared a projection of general education resident students for each of the three elementary schools, out to SY 2020-21.

These figures do not include students in Self Contained Specialized Programs, who are accounted for separately.

In general, there are more students living within an attendance boundary than who attend their home school, due to some students attending other schools on Administrative Transfer or Open Enrollment (usually 1-2% of resident students).


The projection indicated a decrease in the rate of increase at Elmonica, but a resident student population still significantly above the school's building & portable capacity.

The projection showed a continued trend of decline at Beaver Acres and McKinley.



#### Racial & Ethnic Make-up


The racial and ethnic make-up of the three schools was provided to the Advisory Committee.



#### **Advisory Committee Workmap**

To assist the Advisory Committee in evaluating boundary alternatives, staff created a workmap of the three attendance boundaries. Each attendance area was divided into subareas, comprised of one or more Grid Codes (the building blocks of attendance boundaries and the student transportation assignment system).

Each subarea was given an alphabetical identifier, and the map indicated the number of K-5 students who were projected to be within the area in the Fall of 2019.




#### **Advisory Committee Process Overview**

The Advisory Committee met on Saturday, February 2<sup>nd</sup> and Wednesday March 13<sup>th</sup>. Both meetings were open to the public and included public testimony.

At their first meeting, the Advisory Committee received their charge from the Superintendent, as well as background information on the geographic location of the three schools under consideration, historic and projected enrollment, building capacity, demographics and transportation.



The Advisory Committee focused their discussion on two main areas of Elmonica, one in the southeastern portion of Elmonica (Option 1), which includes a mix of multifamily and single-family neighborhoods, bounded by SW 158<sup>th</sup>, SW Baseline Road and the MAX track. This area has seen rapid student enrollment growth in recent years, in part due to a regulated affordable housing development on SW 163<sup>rd</sup> Avenue, which has a high proportion of family-friendly units (2-3 bedrooms). This area was considered by the committee for transfer to Beaver Acres Elementary, given its proximity to that school. Most of this area currently is within Elmonica's Non-Transportation Zone, meaning students walk to school. If transferred to Beaver Acres, students in this area would be provided bus transportation.



The Advisory Committee also focused on the westernmost portion of the Elmonica boundary (Option 2). This area is primarily single-family and attached homes. It is bounded by SW 185<sup>th</sup> Avenue, and Willow Creek, which distinguishes it from the neighborhood to the southeast. Students in this area are provided bus transportation to Elmonica and would be provided bus transportation to McKinley.



The Advisory Committee received spoken testimony from the public and concluded the meeting with a request to staff to provide the projected enrollment, capacity, demographic and transportation impacts of the two proposed changes at the next meeting.


At their second meeting, on Wednesday, March 13<sup>th</sup>, the Advisory Committee received the results of analysis for the two options under consideration.

The projected effect of both Option 1 and Option 2 will reduce Elmonica's enrollment significantly, below its current maximum capacity of 713 (including 13 portable classrooms), but not necessarily below the total building capacity of 466.

The impact to Beaver Acres would be to increase enrollment above the permanent building capacity of 741, but below the total capacity of nearly 900. Beaver Acres has historically been a larger elementary school.

McKinley would see an increase of students above its permanent capacity of 568, but still below its total capacity of 682.

During their deliberation, the Advisory Committee queried the Principals of each school on their view regarding their ability to manage the increase enrollment. The Principals of Beaver Acres and McKinley stated they were able to manage the increases in enrollment due to availability of classroom space, adequate common space such as restrooms and cafeterias, and a desire to help relieve overcrowding at Flmonica.





The Advisory Committee also received information regarding the effects of Option 1 and 2 on transportation. District Transportation staff provided an estimate of the increased cost of transporting students.<sup>1</sup> The majority of the increase in cost would be due to providing bus transportation to an area of Elmonica that is currently in a Non-Transportation Zone. The Advisory Committee confirmed that in the context of the District's \$19 million transportation budget, the increase for the proposed boundary adjustment would be relatively minor.



The Advisory Committee was provided estimates of the potential effect on the racial and ethnic makeup of each of the three schools. Overall, the changes would be minor, with a slight proportional increase in the Asian population at Beaver Acres, and a proportionally smaller Hispanic/Latino and White population at Elmonica. McKinley would see a small increase in the Hispanic/Latino population.







The Advisory Committee also requested the effect of the proposed change to each school's level of poverty, as measured by the percentage of students eligible for free & reduced lunch. Elmonica would see a drop in the share of students eligible for free & reduced lunch, with the other two schools seeing a slight increase.

Finally, the Advisory Committee requested information on how each school may differ in terms of students enrolled as English Language Learners (ELL). The following table shows anticipated changes, which are minor for each school.

#### Superintendent's Consideration of Board Objectives and Policy JC Factors

The School Board adopted two objectives for this boundary adjustment process:

**Objective 1:** Create an attendance boundary amendment that will provide overcrowding relief for Elmonica Elementary School for the SY 2019-20 school year.

**Objective 2:** To the degree feasible, balance future enrollment with each affected school's capacity.

Based on the preceding narrative, the Superintendent finds the Advisory Committee's recommendation meets both objectives. The additional enrollment projected for Beaver Acres and McKinley Elementary schools are proportional to their relative capacity and will provide significant relief to Elmonica in SY 2019-20.

#### **Policy JC Factors:**

#### **Student Body Composition**

The recommended boundary adjustment will result in some minor shifts in the demographic make-up of each school. The Advisory Committee and the Principals discussed the potential implications of lowering the percentage of students who are eligible for free and reduced lunch at Elmonica. This may result eventually in some reduction of Title 1 resources, but the primary objective was to lower Elmonica's overcrowding overall.

#### Current and future availability of space

The recommended boundary adjustment will significantly reduce the burden on Elmonica's permanent building facilities and allow for the removal of the portable classroom structures located at the front of the school from the site. The Beaver Acres campus has received improvements in prior years that make it suitable for a larger student population, and McKinley has sufficient capacity to assist in reducing Elmonica's enrollment. Facilities staff will continue to carefully monitor enrollment and capacity issues at all three schools, as well as consider long-range facility improvements in the upcoming Districtwide Long Range Facility Plan project.

#### Feeder patterns to elementary, middle and high schools

The recommended boundary adjustment will not affect students feeder patterns to Middle or High School.

#### Neighborhood proximity and accessibility

The primary concern for this factor is the area of Elmonica (Area B) that will be transferred to Beaver Acres. This area is within walking distance of Elmonica and was recently designated a Non-Transportation Zone. The proposed change will necessitate resuming bus transportation for students in order for them to attend Beaver Acres. When possible, the District prefers that students are able to walk to school, but in this case, that desire is subordinate to the need to ameliorate overcrowding at Elmonica.

I am concerned about the option to move students to McKinley. Beaver Acres and Elmonica rank about the same with test scores and individual progress. McKinley however has lower test scores and low individual progress along with a reputation of behavior problems. I know McKinley recently gained a new principal, whom parents rave about and claim he will bring change, but he needs time. I believe if nearly 80 new and unhappy students join McKinley next year, giving McKinley a higher capacity rate than Elmonica, would be sabotaging the hope for a brighter future for these students. If the move to McKinley just happen, I ask for a delay move for the 2020-21 school year to give the principal a chance to continue his progress. Another option, would be to allow students to choose if they want to stay at Elmonica, but with no transportation included so parents would be responsible for getting them to Elmonica.
