2019-2020 Selective Service Verification

Current federal law requires all male recipients of Federal financial aid to have complied with Selective Service registration provisions. This includes transgender females that were assigned the gender of male at birth. Financial aid cannot be disbursed until the status of Selective Service registration is determined. This document must be submitted prior to your last date of attendance for the academic year (2019-2020) to be considered for all available financial aid. **Selective Service can be reached by calling 1-847-688-6888, or on the web at: www.sss.gov**

Because Selective Service has not been able to confirm your registration or exempt status, please check one of the boxes to indicate your status:

I HAVE PREVIOUSLY REGISTERED WITH THE SELECTIVE SERVICE. Attached is a photocopy of my Selective Service Registration card, or a printed copy of online verification from the Selective Service website. *You will not receive any financial aid disbursements until a copy of your Selective Service Registration card (or online verification) is submitted to the Student Financial Aid Office.*

You must attach:

- a copy of your letter to the Selective Service that explains your failure to register between
- the ages of 18 and 26, and
- a copy of the response from the Selective Service.

I HAVE NOT REGISTERED WITH THE SELECTIVE SERVICE. I AM EXEMPT FOR THESE REASONS:

- I am a female.
- I am a transgender male who was assigned the sex of female at birth
- I am in the armed forces on active duty. (Does not apply to members of the Reserves and National Guard who are not on active duty.)
- I have not reached my 18th birthday.
- I was born before 1960.
- I am a resident of the Federated States of Micronesia, or the Marshall Islands, or permanent resident of the Trust Territory of the Pacific Islands (Palau).
