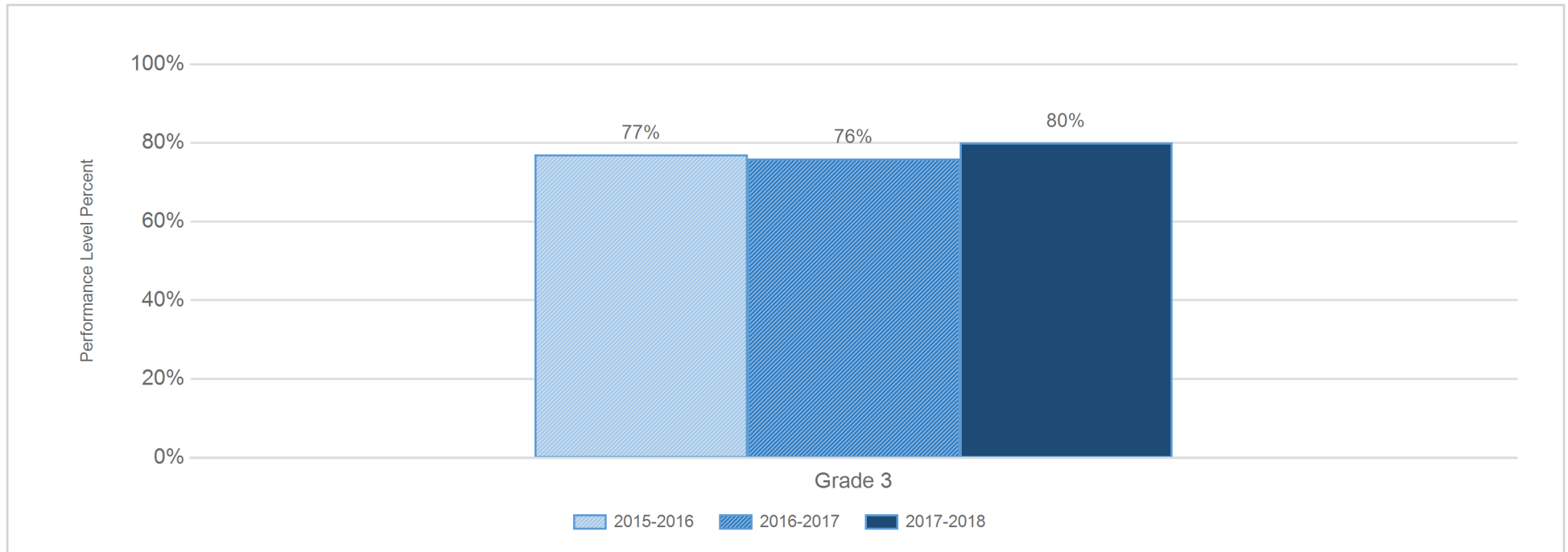

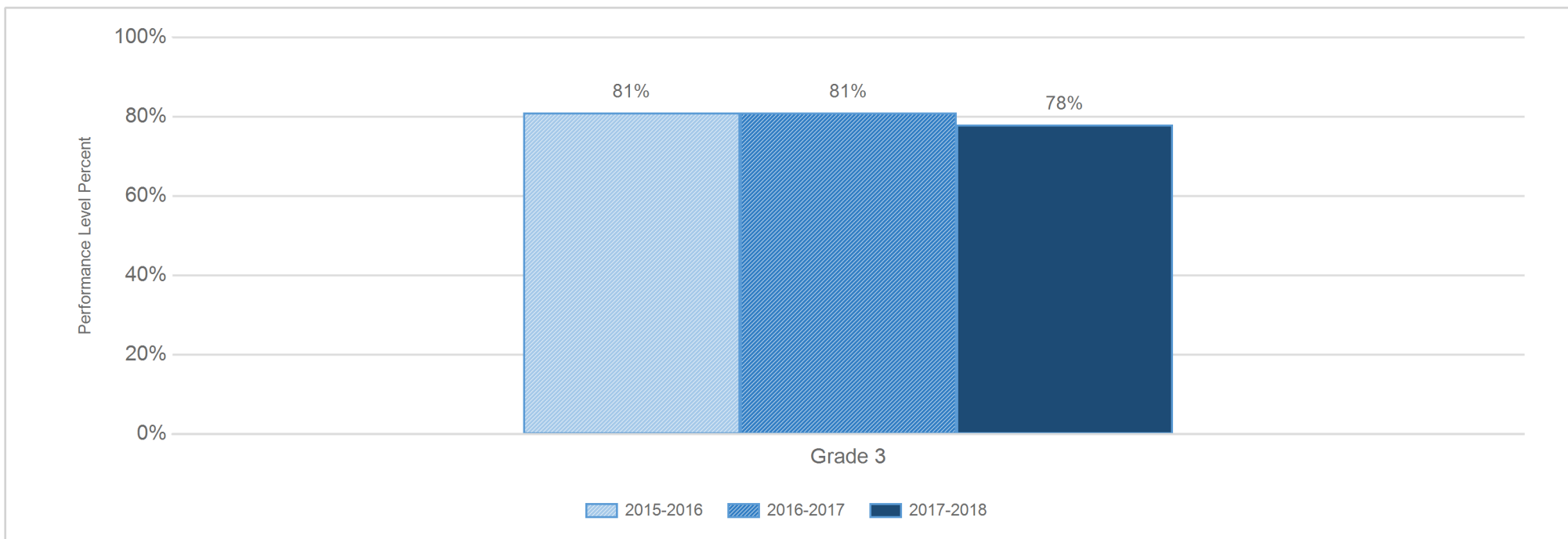

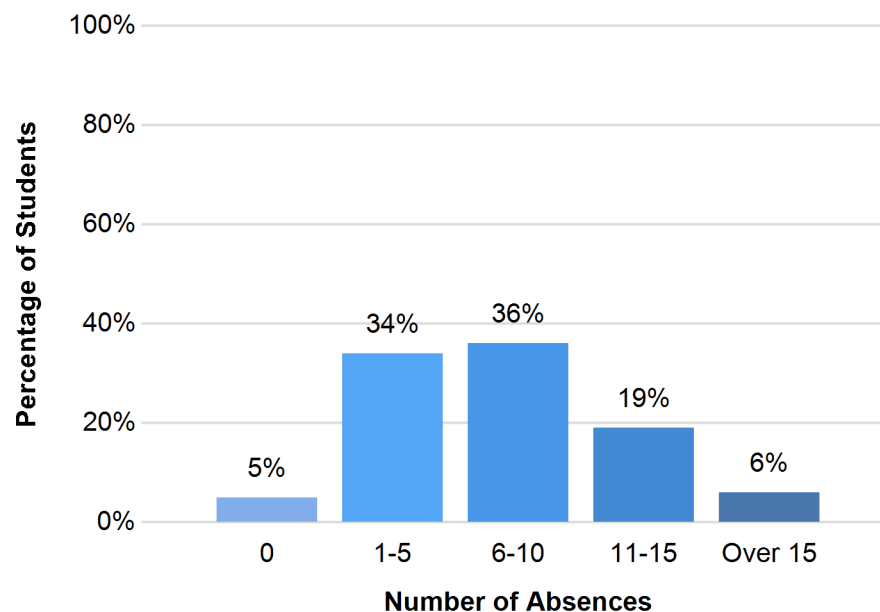

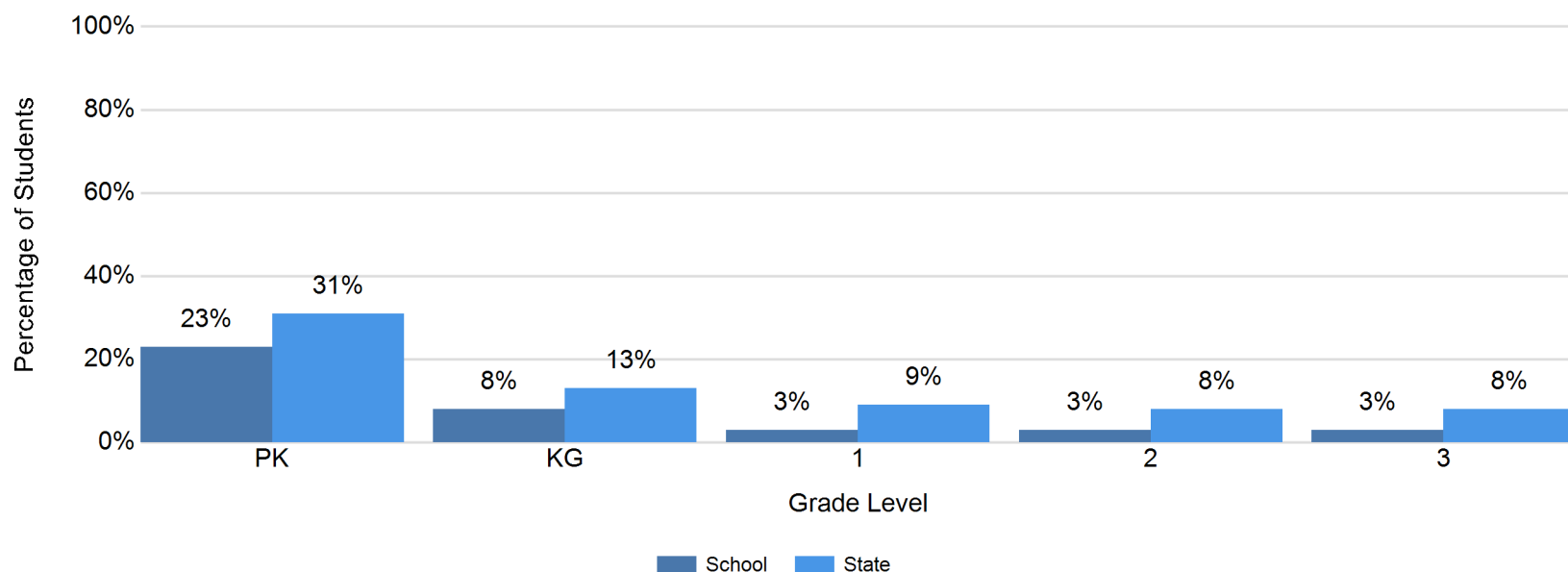

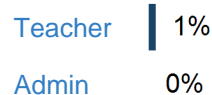

Student Supports and Services:

Our I&RS Committee meets regularly to determine strategies for students who struggle during the day. This may result in actions plans that tie in best practices in teaching, as well as offering our children a basic skills program (Achieve). We offer special services programs based on student needs. Our programs run from our least restrictive environment intervention of a full day in-class support model to self-contained settings for students requiring a more intensive program to meet their needs. We have an ELL teacher who works with students, families, and teachers across our two elementary schools. We also offer a gifted and talented program (Voyagers) that provides these children with enrichment opportunities in and out of their classrooms.



Student Health and Wellness:

Our students have the opportunity to engage in physical education classes throughout the week. The children also have a daily recess period that promotes getting our students outside and engaging in physical activity. Our grade 1-3 students also have health as part of their program through the year. This allows our PE teachers the opportunity to promote health and wellness in a more structured way.
