

Board of Directors, Special Meeting Minutes, Tuesday, May 29, 2018 RICHLAND SCHOOL DISTRICT NO. 400 BENTON COUNTY, RICHLAND, WASHINGTON

School Board President Rick Jansons presided. Board members present: Rick Donahoe, Brett Amidan, and Heather Cleary.

Rick Jansons called the special meeting to order at 4:30 P.M.

EXECUTIVE SESSION (Personnel)

1. Public Interviews for Board Vacancy-Position No. 5

The filing period for these positions is in May of 2019. If the Board is not able to make a selection, the process continues with ESD 123 making the final decision within 30 days. Board members chose numbers to set the order of the vote.
