BUDGET RESOLUTION-2016-03

June 28, 2016

WHEREAS, in accordance with the provisions of Section 687 of the Public School Code of 1949, as amended, the Board of School Directors of the Chartiers Valley School District, on May 24, 2016, prepared a preliminary budget for the fiscal year beginning July 1, 2016, and

WHEREAS, also in accordance with the provisions of said Section 687, public notice has been given more than ten (10) days prior to this meeting and this is the date for adoption of said budget and said budget has been available for public inspection to all persons who may interest themselves for more than twenty (20) days prior to this meeting.

NOW, THEREFORE BE IT RESOLVED, that the budget of the Chartiers Valley School District, Allegheny County, Pennsylvania, as was prepared by the Board of School Directors of said School District on May 24, 2016, be and the same is hereby adopted, as revised and changed at this meeting as the annual budget of the Chartiers Valley School District, Allegheny County, Pennsylvania, for the fiscal year beginning July 1, 2016, said budget as finally adopted being appended hereto, and

RESOLVED FURTHER, that the Board of School Directors of the Chartiers Valley School District, Allegheny County, Pennsylvania, hereby authorizes the appropriation and expenditures of the funds as itemized in said budget during the fiscal year beginning July 1, 2016, and

RESOLVED FURTHER, that the necessary revenue for the same shall be provided by an earned income tax resolution, a deed transfer tax resolution, by a realty transfer tax resolution, by an occupation privilege tax resolution adopted May 25, 2004, and by a realty transfer resolution dated January 9, 2007 and by a school tax on real estate which is hereby levied and assessed at the rate of 16.6067 mills an increase of .3892 mills or \$1.66 on each \$100 of assessed valuation of taxable property.
