Athletics:

Community Service Update:

We have developed a form for community service documentation for community partners to affirm the community service activity that students participate in. This was also presented to student council for feedback, and that feedback was used for a revision of it.

A previous newsletter outlined the community service component and how community partners could reach out to me. We have had a number of community members already reach out about different activities as well as partnerships; we have also have had parents and students reach out about particular projects that they are interested in participating in.

We are in the process of hiring a Flexible Pathways Coordinator, which will help oversee this work. Further, we are in the process of developing the procedures for entering the documentation into student PLPs.

Students & Community:

- Community Forums are held on the third Wednesday of each month. We will resume the community forums in September.
- o Our Science SBAC testing was held on May 22nd. All juniors were required to participate in this annual assessment.
- o Incoming Freshmen Open House (formerly known as Step Up Night) was May 23rd. As we had last year, we included a tour of our building and programs. We had an alternative space set up in the cafeteria for those that did not want to participate on the tour. We still have some refinement of that process, as we had a couple of challenges, but our goal for in-coming parents and students to see highlights of all of our programs and activities, as well as get a sense of our building and connection to our staff, was definitely achieved.

o In partnership with VSAC's Aspirations Project, SHS is hosting a Senior Celebration to honor the great accomplishments and future plans seniors have made. All seniors will be served breakfast, vote on a school motto for college and career readiness activities, complete the senior survey, share their plan for their future in the Photo Booth and celebrate their paths with their peers and teachers. VSAC will give all students "goodie bags" including SHS Grad stickers so they can wear their accomplishment proudly and promote SHS in the community.

Photos from the Photo Booth will be made into a video that will be shared in the cafeteria and hallway displays throughout the remainder of the year so underclassman can see how important it is to make a plan for the future. We hope this celebration is one event of many that will continue to strengthen SHS's college and career culture as part of our work with VSAC's Aspirations Project over the next three years. VSAC's Aspirations Project believes all students should graduate high school with a clear plan for their future that is created through a meaningful PLP and Advisory Curriculum that gives students the information and tools for planning for their future.

O June 7th will be our annual awards ceremony. Many students will be highlighted by departments and for specific awards for academic achievement, personal growth in content areas and/or outstanding work.

My time at Winnisquam Regional High School was the culmination of my student teaching experience. In this school, I taught independently and co-taught with my cooperating teacher in a vast array of classrooms.

The first classes that I taught were two heterogeneous-mixed classes of honors and standard English 9. These classes alternated A and B days in a block schedule and required a heavy level of differentiation and scaffolding because of the population of the class and the time that occurred between each time we met. My lessons focused on student-centered discussions and projects, where students had to draw parallels between the texts in class to their own lives and the world at large.

I also have experience in an alternative classroom consisting of ten Juniors and Seniors who had difficulty performing in a traditional classroom. The goal of the alt school varies from student to student, but with a collective goal of teaching traditional material at a more relaxed pace. These students were particularly lacking in motivation and required additional urging to complete assignments. We read The Crucible and select entries from The Freedom Writers Diary with lessons based in the context of each text to ground students' understanding of the material. Specifically for Freedom Writers, students worked to create a personalized "Soundtrack of Your Life", where students selected ten songs, pulled a quote from the lyrics, included a photo or drawing for the cover image, and wrote a brief summary of the connection they felt it had to their own lives.

I also instructed two sections of Career College Readiness classes. These classes ran for a quarter each as a Junior and Senior level course and a requirement for graduation. In this course, I covered such topics as college entrance essays, banking, credit, budgeting, independent living, interview skills, and a collective community service project that students worked on throughout the course.

Reason for leaving: As this was the internship experience for my final year at Plymouth State University, my time at the school came to a close pending my graduation from the English Education program.
