1. This form must be completed by the parents/guardian and homeowner or renter and signed in the presence of a notary public prior to student(s) starting school.
2. If the parent/guardian and student **are moving into an apartment that is registered in someone else's name, a statement from the apartment manager is also required.** This statement must acknowledge that additional occupants are residing in the apartment and must be typed/written on the apartment complex/manager's stationery.
3. If the parent/guardian and student are moving in with a homeowner, the homeowner must provide the school staff with **proof of residency.**
4. This completed form must be returned to the school of enrollment.
