> Ms. Gena Stewart-President of the Western Wayne County NAACP, addressed the board about the fair treatment of all students, specifically the treatment of Mr. Jackson's son. She asked that the intervention process be looked into when it comes to a student being disciplined for a code of conduct violation. She asked that the school board has some procedures in place to make sure this is fixed.

DIRECTOR OF HUMAN RESOURCES GERARD L. MORIN

> Mr. Keith Stewart addressed the board with his concerns about the assistance given to students who get themselves in trouble. He asked that counselors and coaches work with students instead of telling them they will never play a sport again. These things shouldn't be said and steps should be put in place.

Employee of the Month: Mr. Robert Wolsek, Grogan Elementary Administrator, presented the Employee of the Month award to Ms. Melissa Kochanoski. She is the Young 5's kindergarten teacher at Grogan Elementary. She began working for Southgate Schools in 2001, and has taught hundreds of kids. INFORMATION AND ANNOUNCEMENTS

Mr. Estheimer announced that Shelters Elementary is in need of volunteers for field day Thursday June 6. More information is on the Shelters PTO Facebook page. Shelters carnival is Friday June 7, from 5:00 -8:00 p.m. He and Ms. Pastor attended the Beacon Graduation and he thanked the staff for organizing the celebration. He and his fellow colleagues are looking forward to attending the AHS Honors Assembly tomorrow night, to recognize the accomplishments of the Anderson Grads and with great honor they will attend their graduation on Tuesday June 4. The board will attend the Asher Graduation ceremony on Thursday May 30. He congratulated our hard-working grads.

He gave an update from the Capitol; the senate passed the school aid budget narrowly it was a 21-17 vote on May 22. The house has yet to provide its version of the budget. The Consensus Revenue Estimating Conference met to determine the estimated revenues for the state for the upcoming year. The School Aid Fund was estimated to be \$68 million lower than what was projected in January for the remainder of this fiscal year. The state's General Fund is projected to be higher than the January estimate by \$151.5 million. These figures traditionally drive final budget negotiations. So fingers crossed that will be supported in the House. MASB formally supports governor Whitmer's proposal as did this board on April 9th, including necessary revenue increases.

Mr. Estheimer will be in Lansing next week to encourage passage of that bill and to encourage support of the proposal. The House Education Committee heard a presentation on school mental health. Hopefully this furthers the conversation on what can be done throughout the state to increase mental health services and mental health professionals in our schools.

Dr. Pomponio, in honor of Memorial Day, wanted to recognize public servants as well as the military veterans, teachers, nurses, police and firefighters. She thanked them for their everyday service to the public with support and honor of them.

She mentioned we had an anti-bullying committee, that has been set aside for now, but she wanted the students and public to know that we are still looking at anti-bullying and stressed the importance of always being aware, especially as we enter summer break. Students need to speak up, talk to their parents or a teacher. Bullying is happening whether we know it or not, whether we have a committee or not. She will always support people who struggle with bullying, who are not getting help and try to reach out to someone. She wants students and parents to know we have Ok-to-Say, where they can report anonymously. If students see that friends are being bullied or if they see anything that's happening, it's not tolerated, so speak up, step up, call Ok-to-Say or reach out to a friend. She is advocating for awareness of anti-bullying.

Dr. Pomponio gave her congratulations to the Class of 2019.

Mr. Freitas wanted to send a special thank you to Ms. Amy Sokolowski and Ms. April Schuck for coordinating the 7^{th} Grade Washington D.C. trip. This is a lot of work, but students will remember this for the rest of their lives. He also thanked the staff that attended, making this an awesome trip. He thanked the parents that helped by chaperoning and helping out with all the different fundraising. Their dedication to our students is greatly appreciated and he thanked them.
