

**ARTICULATION AGREEMENT
BETWEEN FISHER COLLEGE AND THE MASSACHUSETTS SCHOOL OF LAW
AT ANDOVER**

AGREEMENT:

Made this 15th day of February 2018 between Fisher College and the Massachusetts School of Law at Andover, Andover, Massachusetts.

PURPOSE:

The purpose of this agreement is to approve a mechanism by which the students from Fisher College may be admitted to the Massachusetts School of Law at Andover upon completion of a specified curriculum of studies at Fisher College. This agreement by Fisher College and the Massachusetts School of Law at Andover recognizes the common objectives, content, and student competencies that exist in programs in specific disciplines common to both institutions.

Based on the identification of common course content and competencies, an appropriate arrangement can be made for students having completed the required specified course of studies at Fisher College to enter the Massachusetts School of Law at Andover and to be awarded a Bachelor of Science in Criminal Justice, or Management, or a Bachelor of Art in Communication and Media Studies or Liberal Arts, at Fisher College following one year of prescribed studies at the Massachusetts School of Law at Andover and a Massachusetts School of Law at Andover Juris Doctor upon completion of his or her studies at that institution. Additional programs at Fisher College may become available and will be updated in the appendix if applicable.

CONDITIONS FOR ARTICULATION:


The following conditions of articulation are hereby set forth:

1. The student must meet all Fisher College admissions requirements and enroll in College as a matriculated student in good standing to be eligible for credit via articulation.
2. The student must complete the Fisher College courses (ninety credits) listed in the attached document that is hereby made a part of this agreement for which articulation credit is being awarded. A cumulative Grade Point Average of 2.7 (B-) must be achieved for College courses and in year three, no lower than a grade of "C" may be awarded.

3. A student who enrolls in this program with a GPA of 3.0 or better at Fisher College will be eligible for a \$5,000 scholarship (per academic year) toward their tuition at MSLAW. To continue receiving this scholarship, students must achieve and maintain satisfactory academic standing at MSLAW (GPA of 2.0 or better).
4. The student must complete the Massachusetts School of Law courses (thirty credits) listed in the attached document that is hereby made a part of this agreement for which articulation credit is being awarded at Fisher College. All courses must be completed with a grade of "C" or better.
5. The student must apply to Massachusetts School of Law at Andover using normal application procedures, meet all applicable deadlines and pay all application fees. The MSLAT will not be required for students who meet the requirements of this program.
6. At the request of the student, the Fisher College Vice President for Academic Affairs (or a designee) will evaluate each student's transcript and certify that the conditions in paragraph 2 above have been met. The Vice President for Academic Affairs of Fisher College will then forward to Massachusetts School of Law at Andover an official student transcript with an appropriate recommendation based on the stated conditions in this Articulation Agreement. In making this recommendation, the Vice President for Academic Affairs of Fisher College will consider the student's moral character and academic promise as factors in arriving at a recommendation.
7. Upon receipt of the student's application and the Fisher College's Vice President for Academic Affairs certification, favorable recommendation, and finding that the conditions in paragraph 2 above have been met, Massachusetts School of Law at Andover will admit the student as a regularly matriculated first-year law student unless the student is not of sufficient moral character.
8. Notwithstanding Fisher College's Vice President for Academic Affairs recommendation, the student must complete the Fisher College curriculum before beginning at Massachusetts School of Law at Andover.
9. This agreement shall commence upon the date of execution of this agreement and shall continue until such time as the agreement is terminated by either of the parties. This agreement may be terminated in whole or in part by either party giving a full (30) days' notice in writing to the other party. However, such termination shall not take effect with regard to students already enrolled until such time as those students have completed their respective course of study.
10. Each school will charge students its normal tuition and fees and will keep the entirety of these funds.

11. Students wishing to receive the Bachelor's Degree from Fisher College under this agreement must meet the normal Fisher College application deadlines and pay the normal Fisher College graduation fees. Students in this program will be eligible for Fisher College graduation after completing the thirty (30) credits of study with a GPA no lower than a 2.0 at Massachusetts School of Law at Andover as specified in the attached document that is hereby made a part of this agreement.

12. Both Fisher College and Massachusetts School of Law agree to the right to use each other's names in print materials and media advertising. All materials must be approved by the respective communications and/or marketing offices at the partner college
