CSEA BARGAINING UNIT EMPLOYEE BEREAVEMENT REQUEST AND/OR VERIFICATION

Bereavement Leave Policy (CSEA Bargaining Unit Contract, 13.1.1)

A classified bargaining unit employee shall be granted necessary leave of absence of three (3) days, or five (5) days if more than 200 miles of travel is required, in the event of death of any member of his/her immediate family. An additional two (2) days shall be granted to either time period if the employee is directly involved in funeral preparations; a written request for these two (2) additional days must be submitted to the Assistant Superintendent of Human Resources for approval.

Members of the immediate family, as used in this section, means the mother, stepmother, mother-in-law, father, stepfather, father-in -law, grandmother, grandfather, or grandchild of the bargaining unit employee and the spouse, and the spouse, son, stepson, son-in-law, daughter, stepdaughter, daughter-in-law, brother, stepsorther, sister, stepsister, and fiancé of the bargaining unit member, or any relative/significant other living in the immediate household of the bargaining unit member. – CSEA 13.1

Verification of Bereavement Leave Upon Return From Leave (CSEA 13.1.4)
