Business

- Approval of minutes from the last meeting: Kristie Gardner made a motion to approve the minutes from our last meeting on September 12, 2017. Brian Schultz seconded the motion. All members in attendance were in favor.

Update on School Goals by Principal Vanessa Mori

- **Goal #1: Increase K-6 students at or above benchmark by 3% as measured by MOY DIBELS scores (k-3 composite and 4-6 fluency).** DIBELS ELA Coordinator Brooke Paras has trained 100% of the tutors. Brooke and Adrienne worked with tutors to write their goals to support this goal. Tutors are in the process of writing and rewriting their goals. Adrienne met with the Local Case Management Team last week and the whole team has now been trained. Composite scores will be gathered this year to use for next year's goal. Comparing middle year to middle DIBELS scores. Teachers have been told to drill down and identify specific student needs. Teachers are meeting regularly in PLCs. Paraprofessionals are working 4 days per week. Six tutors are designated reading tutors and four are designated as math tutors.
- **Goal #2: Teachers will improve in math knowledge and pedagogy to improve student rigor and engagement.** Professional development was offered at the last faculty meeting. Adrienne explained that math drill downs are available to guide interventions. Math and Reading Clubs have started in all grade levels by invitation only from teachers.
- **Goal #3 Students will reduce behavior related referrals by 10% (307+ in 2017 to 270 in 2018).** The school will continue to offer the Mindfulness program (online) to teachers. Vanessa will contact the Mindfulness program and schedule a training for staff.

Mock Evacuation

- Emergency preparedness plan was signed by CC Chair, Krista Nance. Adrienne Kennett reported that 70 BRE employees have read and passed a test proving they understand the plan. The Mock Evacuation will be held at the end of the school day on Wednesday, October 25, 2017. Students will be dismissed at 3pm. Parents and guardians must show teachers their ID and sign for their child. When the bell rings, all students not picked up will be sent home. Daycare and school bus will still come to pick up from the school. Community Council members will be there to help support on the day of the evacuation. Hope Squad meeting will be rescheduled.

Community Questions and Concerns

- Katie mentioned not receiving a call when her student was absent last week. Adrienne will follow through and investigate the call-out system. Teachers are expected to enter attendance no later than 9am. Adrienne will be running a report and sending emails out to teachers not entering attendance on time.
