| | Evaluation | SWIS (School wide Information System) or comparable behavior data system Team Implementation Checklist (fall, winter and spring - online) Self-Assessment Survey – spring - online Tiered Fidelity Inventory (TFI) Facilitation & TA/coaching - Onsite |
| | Fee | \$4,000 per school |
| Year 2: Implementing tier 1 with fidelity | Training | 3 Days School Team Training 3 Half Days Coaches Training 1 half-day onsite coaching/TA visit |
| | Focus | Implementing sustainable tier I systems, integration/alignment, overview of tier 2 and 3 systems |
| | Evaluation | Team Implementation Checklist – fall, winter and spring as needed Self-Assessment Survey - Winter TFI Evaluation - at least annually |
| | Fee | \$3,400 per school |

| Advanced Tiers Academy: By application, with verified tier 1 fidelity & specialized behavior team readiness | Training | 4 Days Regional Team Training for school-based specialized behavior support teams 1 half-day onsite visit |
| | Focus | Developing efficient, effective, data-based systems to provide function-based, tier 2 and 3 behavioral interventions. Establishing data rules for decision-making, matching interventions to student needs and monitoring both fidelity and student outcomes. |
| | Evaluation | Self-Assessment Survey TFI Evaluation – at least annually & as needed for progress-monitoring |
| | Fee | \$3,200 per school |
| Regional PBIS School Team Coaches Network | Description | 3 meetings (fall, winter, spring) from 8:30 to 11:00am open to team coaches from any PBIS schools in the C.E.S. region. Provides opportunity to learn about the latest research, problem-solve implementation challenges and share ideas with coaches from other schools. |
| | Focus | Collaboration among coaches; forum for problem-solving, sharing ideas, resources and materials to help schools sustain positive outcomes from implementing PBIS. |
| | Fee | \$50 per person, 1-time fee for all 3 sessions |
| Customized coaching and technical assistance for individual schools or districts | Description | Classroom, school or district level coaching and technical assistance to improve fidelity and sustainability of PBIS framework. May also include training and ongoing facilitation for SWIS and effective, efficient use of data for decision-making. |
| | Focus | Identifying needs and developing an action plan to address them. Define progress monitoring plan and measureable goals. Goal: Build capacity within schools and districts to implement PBIS with fidelity to improve student outcomes. |
| | Fee | Daily rates: \$1250 per day; \$750 per half day; or hourly on request |
