

RENTON SCHOOL DISTRICT CHROMEBOOK PROTECTION PLAN

The Chromebook Protection Plan (CPP) is an optional (but strongly recommended) plan that provides an inexpensive solution for families to lessen the financial burden if an accident or theft occurs. **The following form must be completed to either purchase CPP or opt out of the plan.**

If parents/guardians opt out of the CPP, they will be fully responsible for any associated cost for damage or theft. The CPP is non-refundable.

* A police report should be filed within 24 hours. A copy of the police report **is required** to file a claim for a stolen Chromebook.

- Two incidents total, in any combination (damage/stolen), are covered per year.
- If a lost or stolen Chromebook is later recovered in working condition, the fine will be refunded.
- All District owned devices must be returned (including the Chromebook, charger, and bag). If a student leaves the district without returning the Chromebook, they will be fined for the full replacement cost, and standard rules for the restriction of records and transcripts would apply. Law enforcement may be involved for the purpose of recovering district property.
- If families choose not to enroll in the CPP, they will be financially responsible for the full cost of repair or replacement of the Chromebook.
- If technical problems occur with the device, the school will provide a loaner laptop while Renton School District's Technology Services repairs the device. Do not take RSD-owned devices to an outside computer service for repair.
- Chargers are **not covered** under this plan.
- Intentional damage is **not covered** under this plan.
