GUSD - Prohibited Fundraising Activities
2019-20 Fiscal Year

1. Rides – Mechanical or Animal Rides
2. Raffles or Game of Chance (approved only for Home & School Club or Booster Club as long as an application is filed and is not during school hours and/or 2 hours after school)
3. Use of Darts or Arrows
4. Alcohol
5. Objects thrown at Live Targets
6. Use of Water Tanks into which a person is Dunked
7. Destruction Old Cars or Similar Objects by Hammers
8. Sales of Cosmetics, Used Jewelry, Makeup Booth
9. Rental of District-Owned Equipment or Facilities to Outside groups
10. Trampolines/Bounce Houses (any rebounding bounces are not allowed)
