## Superintendent's Report

Dr. Washer reported on the Girls Who Code club that is new to Christa McAuliffe Middle School and may soon be coming to other school sites. A segment from Good Day Sacramento was shown that featured the Kindness Campaign at Lois Borchardt Elementary School. Dr. Washer announced that Jeff Simpfenderfer from Liberty High School has been selected the Lodi USD Teacher of the Year. Mr. Simpfenderfer will be invited to a future Board Meeting for recognition. She also announced that Middle College High School has been recognized as a Distinguished School by the California Department of Education.

### **Comments from Board Members**

He stated that Chelsea Vongehr, the District's Public Information Officer is doing a great job. Mr. Neely stated that Senate Bill 126 pertaining to charter school regulations was on the Governor's desk for signature.

Mrs. Macfarlane said she enjoyed a fun weekend at the Science Olympiad that included five high school teams and three middle school teams from Lodi. All in all sixty teams competed in the pouring rain at the event hosted by Ronald McNair High School. She thanked the McNair custodial staff for their contribution to the success of the event.

Mr. Freitas spoke on the sadness of the violence in our community and the senseless killing of McNair High School student Nicholas Sihalath. Mr. Freitas read to students at both Larson and Mosher elementary schools. Mr. Freitas shared that he attended the San Joaquin County AgVenture event (for third grade students) today and that each year the event gets bigger and better.

Mr. Heberle spoke of the Science Olympiad at McNair High School over the weekend and also of the Regional Science Bowl conducted recently in Modesto.
