SOLICITATION ADDENDUM NO. 2 ITB 19-0008 Timberland Middle School Parking Lot Expansion

CHANGES:

The following changes reflect Alternate # 1: Add Turf Field and Irrigation.

THE FOLLOWING IS A SUMMARY OF CHANGES SHOWN ON THE AMENDED DRAWINGS:

- Revise Sheet C000 Add sheets C600, C601 to Sheet Index
- Revised Sheet C300 Added curb along the side of ADA ramp

Minor grade adjustments at ADA ramps, sidewalks and AC paving to better accommodate max allowable ADA grade tolerances.

Revised Sheet C400 Labeled storm drain size for existing system

Trench drain has been revised to be a concrete runnel and detail has been changed. Design allow surface water to flow through the sidewalk and is not connected to the storm system.

Keynote #9 calling out all wye lateral connections, has been added. Contractor to field fit all laterals.

Keynote 4 updated to call out threaded type cleanout cap and fitting

Revised Sheet C510 Perlite media type called out for stormfilters

Detail 1 on C510 has been updated to call out threaded type cleanout cap and fitting

- Add Sheet C601 Turf Field Construction Access Plan
- Revised Sheet L200 Add the following note to Spray Zone Valve: "Note: Provide threaded unions on both sides of the control valve. Provide isolation valve on the mainline side of the control valve."

- Revised Sheet EC01 Clarified inlet protection in the existing parking lot

4. Attachment O – Playground Specifications added (see below).

Playground equipment to be removed prior to add alternate work, except for: Earthwork contractor to salvage/pull play structure poles set in 20"x12" sonotubes. Excavate next to pole, strap pole and remove with concrete base, and set aside for others on pallets Plastic banded or zip-tied together

and to pallet. Surround pallets with traffic barrels and snow fencing (until Final Completion). (approximately 80 poles 2"-6" diameter). Attach detail. Earliest add alternate work start: July 22nd, completed by Aug. 31st, 2019).

- Question: We started digging through the Plans for Timberland MS Parking Lot Expansion and noticed that the Grading Plan Contours are different from the CAD.
