## AUDIT SUMMARY

### Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated May 13, 2015, related to controls related to the associated student body at Lindbergh High School. We appreciate the District's commitment to resolving those matters.

### About the audit

This report contains the results of our independent accountability audit of Renton School District No. 403 from September 1, 2013 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Teacher education and experience (staff mix) reporting
- Special Education enrollment reporting
- Self insurance programs
- Procurement – public works projects
- Associated Student Body cash receipting

## RELATED REPORTS

### **Financial**

Our opinion on the District's financial statements and compliance with federal grant program requirements is provided in a separate report issued in May 2015, which includes the District's financial statements. That report is available on our website, <http://portal.sao.wa.gov/ReportSearch>.

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the District's major federal programs, which are listed in the Federal Summary section of the financial statement and single audit report issued in May 2015. ## INFORMATION ABOUT THE DISTRICT

Renton School District No. 403 serves approximately 15,000 students from preschool through the 12th grade in King County. The District operates three comprehensive high schools, one alternative high school, three middle schools and 14 elementary schools. It also sponsors an early childhood center for regular and special education preschool and kindergarten students.

An elected, five-member Board of Directors oversees the District. The Board appoints management to oversee the District's daily operation as well as its approximately 2,000 employees. The District operates with an annual general fund budget of approximately \$158 million.
