MINUTES

STUDENT COUNCIL REPORTS

Mellon Middle School student council members Maddie Maselko and Anna Conway reported on the activities at Mellon. Eighth grade officers recruited new students by visiting each classroom to present how Student Council works. As a result, a record number of sixth and seventh graders are participating.

The first fundraiser of the year made over \$500 for cancer patients at Children's Hospital. The fundraiser efforts continued with a bake sale and Pink Out sale at Mellon's open house. Upcoming events include the stocking blitz for Military Connections and the Book Fair.

High School student body co-presidents, Nick Lies and Billy Moorhead, reported on the activities in the High School. Before school officially started, the Link Crew program was launched. Juniors and seniors were trained on how best to welcome the freshman class to Mt. Lebanon High School. Senior activities include the annual boat ride on September 15 and the Homecoming Parade on October 18. Upcoming events include Spirit Week, the Homecoming Dance on October 26 and the ever popular Halloween Door Decorating contest on October 31.

The Great Alumni Award Luncheon and Ceremony was held on September 27. Six alumni were recognized for their important contributions to the business world, to college athletics, in developing a STEM middle school, on behalf of nonprofit organizations, and taking care of children with HIV/AIDS, tuberculosis and malnutrition in an African country. Five of the six awardees, Kim Frock, Richard Lackner, Preston McMurry, Jr., Bill Roth, and Eric Schmude were able to attend the luncheon and evening recognition program. Dr. Jason Bacha was needed in the medical clinic in Mbeya, Tanzania and was unable to attend.

BOARD PRESIDENT'S REPORT

Mrs. Cappucci reported that the Board will be taking action on several personnel items this evening—the retirements of Assistant Superintendent Dr. Deborah Allen and Director of Special Education, Mrs. Connie Lewis; and the extension of new five-year contract for Assistant Superintendent Dr. Ronald Davis. Dr. Allen and Mrs. Lewis have worked in the District for 26 and 14 years, respectively and the Board thanks them for their many years of service. Dr. Davis has been an asset to the District and the Board is pleased to offer him this five-year contract.

Dr. Steinhauer, Ms. Klein and Mrs. Cappucci made a presentation at the annual PSBA School Leadership Conference on Student Centered Budgeting. They were able to share the District's method of budgeting in which decisions are made based on affects in the classroom and on student learning, as well as fiscal effect. The session was well-attended by other school board members, superintendents, and business officers who were very interested in the District's thoughts on budgeting.

The board president spoke of the Great Alumni Awards. Each year, a group of alumni are nominated for this award based upon their exceptional work in improving the lives of others, involvement in community service, and/or achievement in a professional field. This year's Great Alumni have given back to their communities, and the communities throughout the world. They include a pediatrician working with AIDS patients in Tanzania, a business woman who founded a school for Math and Science, a college football coach who has mentored countless young men, an advertising/marketing executive who started a charitable organization aimed at preventing domestic violence, a college sports radio broadcaster who works with disadvantaged youth, and a business man who has worked extensively with several organizations, including the Arthritis Foundation, Autism Speaks, and the Tourette Syndrome Association. Mrs. Cappucci congratulated this year's awardees.

SUPERINTENDENT'S REPORT

Dr. Steinhauer reported that every year the Board takes the opportunity to acknowledge the work of the PTA in schools. For over 75 years, the PTA has been a key partner of the District, helping us to provide the best education possible for each and every student. On behalf of the students, staff and the Board of School Directors, the superintendent thanked all of the PTA volunteers who work tirelessly and volunteer thousands of hours each year to make our schools a better place for children. The superintendent was proud to announce that Mt. Lebanon High School had 11 students designated as National Merit Semifinalists in the 2014 National Merit Scholarship Competition. These students are among the academic elite in the country. Congratulations to Mt. Lebanon High School senior Callie Frey who successfully defended her WPIAL singles tennis championship this fall. Last year Callie became the first Mt. Lebanon girls' tennis player to win a WPIAL singles title since 1984.

Ms. Louise Marino and representatives of the High School Marching Band presented a check to the District in the amount of \$378 that will be donated to the Mt. Lebanon Band Instrument Fund. The funds were raised at a car wash held in August.

Lincoln Elementary was named a National Blue Ribbon School for 2013. This is Lincoln's third National Blue Ribbon. The National Blue Ribbon School award affirms the hard work of students, educators, families, and communities in outstanding schools. Lincoln School will mark their designation as Blue Ribbon School on October 24 at 2:30 p.m. with a parade around the Lincoln community, ending with a ceremony on the school playground. Dr. Marybeth Irvin will be honored on behalf of her school at a recognition ceremony on November 18-19 in Washington, D.C.

Dr. Steinhauer introduced District librarians Bridget Belardi, Christy Smith, and Cassie Mader who presented an overview of the library program in the elementary, middle and high schools.
