



1.1 Program Summary

- (Completed) April 10, 2018 Orange HS Increment # 1 (Satellite Kitchen) (04-116673.2)
- (Completed) March 1, 2018 Orange HS Increment #1 (Infrastructure Upgrades, Move Relocatable Buildings, Bus Drop-Off, Restroom Renovation Project) (04-116673.1)

1.2 Program Highlights/Key Milestones

May 9th & May 23rd Approved Board of Education Items:

- A contract for the RMA Group for Site Scan Land Survey services for the parking lot renovation activities at Villa Park HS. This work will help the LPA design engineers with the information needed on flood control outlets and improve overall site drainage.
- A fixed fee for gkkworks/CANNON Design in order to facilitate the conceptual design and stakeholder process for Measure S Phase II projects at Canyon High School, in the amount of \$43,500.
- Amendment # 3 (listed as Amendment # 1 in the 4-18.2019 Board Approval), should have read; "Amendment # 3 – Cordoba Inc. – Furniture, Fixtures and Equipment Coordination and Consulting for all Measure S projects. The proposal amounts listed were correct to add the services of an FF&E Project Manager for the Measure S Bond projects in the amount of \$297,750.

the lowest responsive responsible bidder was, Swinerton, in the amount of \$38,400,000, whose bid is also within the estimated budget for this project.

- On 5/23/19, Lionakis presented the Phase II conceptual process for Orange HS outlining design options to the public at the Board of Education meeting.
- On 5/23/19, gkk/Cannon held a planning meeting at Canyon HS library with students, parents and school staff to go over the planning outlines and prepare options to pursue.
- On 5/9/19, HED presented the Phase II conceptual process outlining options for El Modena HS and LPA presented the Phase II conceptual process outlining options for Villa Park HS, to the public at the Board of Education meeting.
- On 5/2/19, Lionakis held a planning meeting at the Orange HS cafeteria, to go outline the three options that they have with the students and faculty of Orange HS. There was feedback from the group on the option that they preferred.






