



**White Bear Lake Area Schools
School Board Meeting Highlights
July 15, 2019
Regular Meeting**

At the July 15, 2019 Regular Meeting of the White Bear Lake Area School Board, the following items were presented and discussed:

1. **Review of Minnesota State High School League “Why We Play” Training Video.** Superintendent Wayne Kazmierczak presented the School Board with a “Why We Play” training video that they will review, as required by the Minnesota State High School League. The video defines the purpose of education-based athletic and activity programs and will assist school communities in communicating a shared common language as it relates to the value of these said programs, prior to approving the 2019-20 Resolution for Membership.

2. **Overview of Comprehensive Facilities Plan.** Superintendent Wayne Kazmierczak presented an overview of the Comprehensive Facilities Plan that was developed by a 90-member Facilities Planning Committee during the 2018-19 academic year.

At the June 10, 2019 Regular Meeting of the White Bear Lake Area School Board, the following items were acted upon:

1. **Action on 10-Year Long-Term Facility Maintenance Plan.** The School Board approved the 10-year Long-Term Facility Maintenance Plan as presented.
2. **Action on Designate of Identified Official with Authority for the MDE External User Access Recertification System.** The School Board approved Wayne Kazmierczak, Superintendent, and Jody Reber, Executive Assistant to the Superintendent (to add and remove names only), as White Bear Lake Area Schools’ Identified Official with Authority as required by the Minnesota Department of Education.
3. **Action on 2019-20 Resolution for Membership in the Minnesota State High School League.** The School Board approved membership in the Minnesota State High School League for 2019-20.
4. **Action on Resolution Relating to the Issuance of School Building Bonds and Calling an Election Thereon.** The School Board approved the Resolution Relating to the Issuance of School Building Bonds and Calling an Election Thereon as presented.

5. **Action on Resolution Relating to the Election of School Board Members and Calling the School District General Election on November 5, 2019.** The School Board approved the Resolution Relating to Election of School Board Members and Calling to School District General Election as presented.
6. **Action on Changing Polling Location in White Bear Township.** The School Board approved the resolution to change the polling location for White Bear Lake Township P-2 to the Lakeshore Players Theatre.
7. **Action on School Policy.** The School Board acted upon the following policies, as recommended by the Policy Committee and Cabinet:
 - a. 413, Harassment and Violence
 - b. Policy 504, Student Dress and Appearance
 - c. Policy 506, White Bear Lake Area School District Student Discipline Policy
 - d. Policy 525, Violence Prevention
 - e. Policy 611, Homeschooling
