

After School Program – Burlington Public Schools 2019-2020 School Year

Who: The After School Child Care Program is available to children enrolled at the Francis Wyman, Fox Hill, Memorial, Pine Glen Elementary Schools and the Marshall Simonds Middle School (MSMS).

Where: We offer 5 After School Program sites serving the 4 elementary schools for grades 1-5 and a **NEW** program at the MSMS. Kindergarteners from Fox Hill, Memorial and Francis Wyman will be served at the Francis Wyman Site. The Kindergarteners from the Pine Glen School will stay at the Pine Glen.

- The program in the Francis Wyman School is located in dedicated space and has use of the gymnasium, cafeteria, conference room and outdoor playgrounds. All Kindergarten students from the 3 elementary schools will attend the Francis Wyman site and will be delivered by bus. **Grades K-5**
- The program at the Memorial School is located in Room 172. The Memorial program has use of the outdoor playground and the gymnasium. **Grades 1-5**
- The program at the Fox Hill School is located in the cafeteria and has use of the gymnasium and outdoor playground. **Grades 1-5**
- The program at the Pine Glen School is located in the cafeteria and has use of the gymnasium and outdoor playground. **Grades K-5**
- The Middle School program will be located in the cafeteria at the MSMS.

When: The After School Program is available to kindergarten students from kindergarten dismissal until 6:00 p.m., or from kindergarten dismissal until 3:00 p.m. It is available to children in grades 1-6 from the afternoon dismissal until 6:00 p.m. Please see the registration form for registration options.

Cost: The After School Program does not charge registration or membership fees nor does it charge additional fees for no school days, special programs, field trips, transportation, or snacks. There is a reduction in tuition per child for families with multiple children in the program and for families who qualify for free or reduced lunch.

Staff: The After School Program is staffed by experienced elementary school teachers, childcare professionals, and teachers' assistants. A staff/child ratio of 1:9 is maintained in the kindergarten program. A staff/child ratio of 1:10 is maintained in grades one through five and may increase to 1:13 for Middle School.

Activities: The After School Program offers a variety of educational and recreational activities throughout the school year such as creative theater, computers, sports programs, animal adventures, cooking, science, etc. New programs are developed throughout the year. Snacks are provided for kindergartners upon arrival at the After School Program, and for children in grades kindergarten through five around 3:15 p.m. All fees associated with activities and snacks are included in the monthly tuition rate.

No School Day Coverage: The After School Program provides childcare coverage from 7:30 a.m. to 6:00 p.m. on staff development/conference days, half days, and vacation days (the program will be closed on snow days and most holidays). This service is provided at no additional cost to children enrolled in the 6:00 p.m. program for the days each child is registered for. Kindergarten children dismissed at 3:00 p.m. are not eligible to attend the program on no school days. When space allows additional days may be added to your regular weekly schedule for an additional fee of \$50, this applies to 3:00 pm Kindergarten children as well.

To enroll your child in the After School Program: Complete and return a registration form by February 27, 2019. Forms can be mailed to **The After School Program, Francis Wyman School, 41 Terrace Hall Ave, Burlington, MA 01803.** For children who are not currently enrolled in the After School Program, participation in the 2019/2020 After School Program will be determined by a lottery held during the week of **March 4, 2019** should it be necessary. Written confirmation of a child's enrollment status will be emailed within two weeks of the lottery.
