## **Program Description**

Willow Community Day School (WCDS) is an alternative education program that serves expelled students (DRB), students referred by the School Attendance Review Board (SARB) and the Back on Track (BOT) Program for students that are struggling academically and in need of credit recovery, as well as, learning essential study skills. All community day school students are required to attend 360 minutes per day. **Our goal** is to assist at-risk youth to overcome academic and behavioral barriers that have previously hindered school success.

Curriculum aligns with District Grade Level Standards of Achievement and required district courses. Students enrolling at Willow CDS may have deficiencies in basic skills and need systematic and intensive instruction in order to be successful in general education classes. Willow CDS offers a smaller (teacher and paraprofessional ratio to student) that allows for a more individualized and small group instruction. The curriculum stress acquisition of basic skills in reading, language arts, and mathematics. Cross-curricular instruction in subject areas such as social studies, science and health assist students while they acquire the skills to be successful. Creative and hands-on methodologies deliver curriculum so students can master what they failed to learn in traditional academic settings.

#### Goals

- ✓ All students will address and work towards improving academic and behavioral setbacks while progressing academically.
- ✓ All students will increase daily attendance and total hours committed to learning.
- ✓ All students are recognized and rewarded for improvement in behavior, attendance and academics.

#### Referrals

TUSD Student Services, Discipline Review Board (DRB), Student Attendance Review Board (SARB) make referrals to Willow CDS. Referrals are also accepted from students' zoned school counselor (BOT/credit recovery program only).

#### Services

- Comprehensive group counseling provided in eight-week sessions during the school day.
- ✓ Students mandated to complete Anger Management and/or Substance Abuse counseling by the District Review Board (DRB) **must** complete the sessions outside of the school in order to qualify for reinstatement to the regular academic program (zoned resident school).
- ✓ Academic Counseling provided

## **Roles and Responsibilities**

- ✓ **Students:** fulfill requirements of their DRB, SARB and BOT contracts. Fulfill onsite requirements as part of participation at Willow CDS.
- ✓ **Students:** are responsible for regular attendance and positive behavior.
- ✓ Students: meet all academic performance expectations.
- ✓ Teachers: are responsible for student supervision.
- ✓ Teachers: are responsible for direct instruction, assessment, review, and development
  of materials for students at Willow CDS.
- ✓ **Administrator:** oversee placements from the District Discipline Review Board, the Student Attendance Review Board and on-site academic and behavior teams.
- ✓ Administrator: make recommendations for student placement back into regular programs. Administrator will work with on-site staff to see the successful operation of Willow CDS.
- ✓ Administrator: determines that the student has met the criteria from the District Discipline Review Board, Student Attendance Review Board or on-site attendance and behavior requirements. Willow CDS Administrator will refer the student back to the board or panel for possible readmission into regular school programs.

## **Academic Performance Expectations**

- ✓ Performance as stated in DRB and SARB contracts
- ✓ Maintain a 2.0 GPA
- ✓ No F's
- ✓ BOT Students must earn 5 recovery credits per quarter
- ✓ Progress Reports are mailed mid quarter. Quarter report card grades are mailed home at the end of every Quarter/Semester.
- ✓ Parents are encouraged to check their student's grades by accessing the Aeries.net Parent Portal and contact teachers via email regarding questions and concerns.

## **Homework Policy**

✓ Willow CDS students are not assigned homework. However, all students are encouraged to work independently at home in their online course/s.

## **Grading Policy**

The purpose of grading is to communicate the level of achievement in the educational program to students, parents, institutions of higher learning, prospective employers, counselors and other schools the student might attend. The symbols used and the meanings of each symbol are as follows:

## Discipline Philosophy and Policy

It is important that each individual develop sound social judgment and frequent opportunities to exercise this judgment and the self-discipline, which must accompany it.

Students and teachers are entitled to an environment in which maximum learning and teaching can take place. In order to guide students to become responsible, self-disciplined individuals who are free to pursue academic studies, an appropriate amount of external discipline might be necessary.

All societies have rules. The expectation is that all students obey all classroom and school rules. Our aim is to improve the learning environment through positive reinforcement of good behavior and consistently applied consequences for inappropriate behavior.

## **Saturday School Hours**

Students enrolled with Saturday School Hours are expected to serve them after school while in attendance at Willow CDS. Saturday School Hours can be served twice a week, up to one and a half hour  $(1 \ \frac{1}{2})$ .

#### **Attendance Procedures**

- ✓ All students are required to attend 360 minutes per day. Willow School will maintain accurate records of student attendance.
- ✓ There are no excused absences at Willow.
- ✓ Parents send students to school and/or promptly notify Willow School if their student is going to be absent.
- ✓ If you have been very ill and have a doctor's note to verify illness, your absence may be excused. A doctor must list dates you were out **and the diagnosis**. Blanket notes that state "was seen on \_" will only count for the dates listed on the note. This note must be presented the day you return. Notes presented after that date will **not** be excused.
- ✓ Should an absence occur, please contact us at 830-3357 between the hours of 7:30 - 9:30 am. Please clear all absences and tardies within 48 hours.
- ✓ Parents are encouraged to check their student's attendance on a regular basis by using Aeries.net Parent/ Student Portal.

NOTE: Students on SARB contract, please be mindful of additional attendance requirements as stated on your contract.

#### **Attendance Consequences**

Students missing three (3) days in a quarter (or the equivalent of a quarter) or six (6) days in a semester (or the equivalent of a semester) will be dropped from Willow. In situations of documented severe illness, exceptions.

## **Truant Policy**

Students late thirty (30) or more minutes in 1st period will be considered as truant for the day, but will be allowed to attend class and will get credit for their work.

## **Tardy Policy**

#### A little late is too late!

Every instructional minute counts and student tardiness interferes with the learning process. Please be respectful of your teacher and fellow classmates and be on time to class.

- ✓ Three (3) unexcused tardies (including truancy) is equal to one (1) unexcused absence.
- ✓ One truancy (30 minutes late) is equal to one (1) unexcused absence.

## **Dress Code Policy**

Acceptable school colors include Black, White, Tan or Gray (solid colors only)

- NO HATS or HEAD COVERINGS
- NO PURSES OR BACK PACKS
- NO CHAINS OR STUDDED ACCESSORIES
- NO LOGOS OR EMBLEMS, i.e. NIKE, Sport Teams, etc.

#### **TOPS**

- MUST be in dress code colors only Black, White, Tan or Gray (SOLID COLORS ONLY)
- T-Shirts, Collared shirts or Turtlenecks
- Long Sleeve or Short Sleeve
- No Spaghetti straps or Tank Tops
- No tops that expose the skin at the waist or midriff or any inappropriately revealing clothing

#### **PANTS**

- MUST be in dress code colors only Black, White, Tan or Gray (SOLID COLORS ONLY)
- NO SAGGING, NO RIPPED PANTS, NO BLUE JEANS, NO SHORTS

#### **SHOES**

- MUST be in dress code colors only Black, White, Tan or Gray (SOLID COLORS ONLY)
- SHOES MUST BE LACED
- NO BACKLESS SHOES OF ANY KIND, HOUSE SLIPPERS OR SANDALS

## **JACKETS/SWEATSHIRTS**

- MUST be in dress code colors only Black, White, Tan or Gray (SOLID COLORS ONLY)
- NO LOGOS OR EMBLEMS

## **BELTS**

Any belt worn with pants

- May not hang below shirts
- No gang related OR inappropriate logos/images on belt buckles

## **ACCESSORIES**

• No accessories in **RED** or **BLUE**, or <u>any other accessories deemed inappropriate by school staff.</u> Including nail polish and hair color.

#### **Cell Phones Policy**

- To avoid unnecessary classroom disruptions, we are unable to deliver messages to students except in cases of **extreme** emergencies.
- Students may use cell phones before school, during lunch and after school.
- Cell phones must be turned off and out of sight during the instructional day.
