1. \_\_\_\_\_ I can create and maintain a study schedule without face-to-face interaction with a teacher.
2. \_\_\_\_\_ I will adhere to the school's timelines for completion of course requirements. The **Wyandotte Public School** policies will take precedence in meeting program/course requirements.
3. \_\_\_\_\_ As a student, certain standards are expected of me. Appropriate Use of the Internet is expected at all times. All terms outlined in the District's Acceptable Use Policy, Student Code of Conduct, and Academic Honesty Policy apply to this contract.
4. \_\_\_\_\_ All course work and submission that I do may be retrieved and/or monitored by the mentor teacher at anytime.

6. \_\_\_\_\_ I must communicate with my mentor as well as my online teacher on a weekly basis.
7. \_\_\_\_\_ I must not inappropriately use information within the course.
8. \_\_\_\_\_ I must follow all other rules as specified by the district, mentor, and online teacher.
9. \_\_\_\_\_ Weekly contact with the mentor teacher is mandatory. If you cannot contact the mentor, then reasonable attempts should be made via telephone if email is not possible. More than two (2) unexcused weeks of contact may result in removal from the program.
10. \_\_\_\_\_ I will be committed to the courses, adhere to the course schedules as prescribed, and I understand that drops will be allowed only as outlined by the online provider and the Wyandotte Public School add/drop procedures.
11. \_\_\_\_\_ I understand that the courses will be listed on my transcript or permanent academic record.
12. \_\_\_\_\_ I must still take all local and state assessments (i.e., MEAP, MME, NWEA-MAP) as scheduled (if applicable).
