About PAD



PAD Screening will provide parents with objective developmental information that can be shared with pediatricians and preschool programs.

Stonington Public Schools offers PAD (Preschool Assessment of Development), a developmental screening for children 2 years, 6 months & 5 years, 11 months. PAD assists parents in the monitoring of the developmental growth of their children and identifies those who may need some type of intervention. Children eligible for PAD reside in the town of Stonington or attend a preschool located in the town of Stonington.



A trained preschool team will screen any child between the ages of 2 years, 6 months & 5 years, 11 months. Screenings are by appointment only and may be scheduled by contacting the Special Services Office. Screenings are held monthly during the school year.

Screening Components Include:

- 👤 Parent questionnaire
- 👤 Developmental screening including speech/language, concepts, and motor domains
- 👤 Hearing/vision screening
- 👤 Description of PAD screening process and typical peer program by a preschool special education teacher

Screening Team:

- 👤 Nurse
- 👤 Speech/Language Pathologist
- 👤 Occupational Therapist
- 👤 Physical Therapist
- 👤 Special Education Preschool Teacher
