COBIS Student World Debate Competition 2020 Terms and Conditions

The COBIS Student World Debate Competition will take place between 5-8 February 2020 in Marbella, Spain.

Registration

Online registration will open from 11 September 2019 until midday (BST) on 25 September 2019. Schools that wish to participate in the COBIS Student World Debate Competition 2020 must register at www.cobis.org.uk/debate during the stated timeframe. Please ensure that you speak with students, parents and governors during the registration window so that if you need to withdraw, you can do so before the end of the registration period.

Lottery System

There are 16 places available at the COBIS Student World Debate Competition 2020. Some places are pre-allocated, as seen below.

Pre-allocated places:

1. 2020 host: English International College, Spain
2. 2019 host: International British School of Bucharest, Romania
3. 2018 host: Jumeirah College, UAE
4. 2019 winning team: Dubai College, UAE

The remaining 12 places will be allocated by a lottery draw on 25 September 2019. Registered schools that are not selected in the lottery draw will be placed on a waiting list.

Student Teams

- Schools should bring students who are in Years 11-13 and are aged 16 and over. Younger students are permitted but it is recommended that these students enter the COBIS U16 Debate Competition.
- Schools may bring a team of between four and six students.

Finance

- Schools must pay the deposit, balance and accommodation fees in a timely manner, in accordance with the timeline specified on all invoices.
 - The deposit invoice of £295 per school will be issued by The English International College during the week commencing 30 September 2019 and must be paid within 28 working days.

- If a school does not pay their deposit payment by the date shown on the invoice, their place will be revoked and offered to a waiting list school that was not selected in the lottery.
- If a school/student withdraws after 28 October 2019, the deposit will be retained.
- The deadline for payment of the remaining amount (participant fees) is 13 December 2019.

Travel and Accommodation

- Schools must not make any arrangements to travel to or stay in Spain until their place has been formally confirmed by COBIS and the host school.
- Schools must take out the appropriate insurance policies in order to attend the competition; the policy should include travel, medical and cancellation insurance as well as anything else as required by your school or region.
- Schools must ensure that all participants' passports will be valid for a period of at least six months from the date of the competition.
- Students and staff travelling on a non-EU passport requiring visas are encouraged to apply for visas early as the process can take up to two months.

Cancellation

- COBIS and the host school reserve the right to cancel this event if insufficient bookings are received, or if travel to the host country becomes inadvisable.
- Schools must take out the appropriate insurance policies in order to attend this competition; the policy should include cancellation, travel and medical insurance as well as anything else as required by your school or region.

Data Sharing and Processing

- In order to administer this event, COBIS/the host school will collect student names, ages, dietary requirements and team photos, as well as passport details if required for visa support letters/accommodation reservations. Please ensure that you have obtained the correct consent from pupils or guardians when providing this information. COBIS may ask for evidence of this consent.
- COBIS will also collect lead teacher, head teacher and finance names and contact details. Information will be collected by COBIS via an online form created in COBIS' website (Finalsite). This data will be shared with the host school for the administration of the event. COBIS and the host school will have a data sharing agreement in place to protect the transfer of this information. This information will not be passed by COBIS to any other parties.
- Lead teacher and school contact details will be retained by COBIS for record keeping purposes. All other personal student data will be deleted after the event has taken place in line with COBIS' data retention policy.
