### 1. 2020 Enrolment fees

### 1. 2020 Tuition Fees

Fees are paid by the Semester (half-yearly) in advance. Fees per annum:

Senior School	Years 10 to 12	\$38,527

The tuition fees cover all tuition costs, camps, excursions, some text books and technology levy.

Where required, additional English lessons are provided; in individual cases it is sometimes necessary to charge for intensive English classes to ensure the student's level of English is of an acceptable.
