



## Student Registration 2020 LANGUAGE IMMERSION TRIP TO FRANCE AND SPAIN

Both Bear Creek and Xperitas registrations and deposits **due Tuesday, October 15, 2019.**

### Trip Includes

French and Spanish III and IX students will travel to France and Spain, April 7 – 18, 2020.

- Bear Creek fee of \$400 includes:
  - Cancel for Any Reason Trip Insurance (50% trip cost within 48 hours of trip for any reason)
  - Four (4) dinners - Two group dinners in Barcelona and two group dinners in Paris.
  - Chaperone supplement.
  - If student participation is below minimum of 15, trip will be re-evaluated, and additional costs may be presented as an option.
  - Any cancellations must go through Xperitas and insurance and will not be reimbursed by the school.

### Responsibility

Student participation waivers and parental release forms will be distributed prior to travel and require student and parent signatures.
