- Budget is low due to 4x4 schedule extra productivity for teachers is required  
Budget was for 5 productivity classes but currently have 9. We need approximately \$30,000 to cover costs
- Re-allocation of funds to cover extra expense. Motion to amend the budget by Brynn Clinger, seconded by Joani Stevens. The motion passed unanimously.
