What is the goal for this fencing project?

Secure the Environment around Portables and Field area

The Standards list fencing but we are wanting the decorative tubular black steel.

Regarding DQ-40; Pipe needs to match existing at Beaverton HS (schedule-40). BSD is willing to go to DQ-40 at Westview. 3-rail system needs to match existing at both schools.

Approved Product: Montage Plus Majestic 3 Rail by Ameristar Fence

Man-gates- Egress panic gates

There is reference to panic hardware at egress gates on "*Attachment L Fence Drawings*"

To clarify, BSD wants panic/self-closing hardware installed at egress gates.

Panic hardware type; Von Duprin LD-99XP-NL. Ensure correct crash bar size (3' or 4') correlates to gate size.

BSD requires a C-channel shaped metal around the panic hardware to provide a backer plate for the exit device to mount to, reduces direct rainwater on hardware, and reduces the likelihood that someone could open the door from the

exterior by looping a rope/wire around the panic bar to release it. See photo examples installed at other schools attached. Swing gates/By-pass gates are to be determined. No ADA kick plate are needed.

Will there be any additional prints/drawings coming out prior to the bid closing?

Please use the drawings provided in this solicitation for bidding.

Are there events at the school that will get in the way of this construction?

No, we will coordinate with the contractor to get these areas cleared so there won't be any problems of student/staff being in the way.

Does everyone need to be badged by BSD?

Yes

Can we go to other sites on our own?

Yes, just check into the office and let them know you are there.
