## Regular Meeting of the Board of Trustees July 24, 2014

Lee Wallace, president of the Board of Trustees, called the meeting to order. Following the pledges to the American and Texas flags, Angie Garza-Viator, principal of La Porte Elementary School, gave the invocation.

## Superintendent's Reports
