President Linda Chavez welcomed everyone and led the Pledge of Allegiance at this time.

Public Comment:

Superintendent Bauer received a message from Clerk Dolores Marquez-Frausto asking if the Board would consider tabling this item.

President Linda Chavez commented Clerk Dolores Marquez-Frausto was given the opportunity to be here today but she is at a conference.

Member Corina Herrera-Loera read Board Resolution #08-19/20 Censure of Board Member Dolores Marquez. She said in the interest of fairness she presented this resolution for consideration.

MOTION #04-01 by Corina Herrera-Loera to place resolution today on the agenda for our next regular board meeting on October 10, 2019; if Dolores Marquez has a response, she is to place it in writing, before the meeting. Response should include publicly disclosing the substantiating the source of the \$5,000 cashier's check referenced in the August 15, 2019, California Fair Political Practices Commission approved Stipulation, Decision and Order Case Number 17/0106 to assure the board and public there is no conflict of interest on any matters before the Board of Trustees. MOTION #04-01 was seconded by Member Andrés Quintero.

Vice-President Ernesto Bejarano said he wanted to make an amendment to the resolution to add remove Dolores Marquez from the Bond Committee effective immediately upon approval of the resolution. He asked Counsel Peter Rehon if that would be alright.

Counsel Peter Rehon replied a censure is a formal process one or more its members had a violation it cannot affect Board member's responsibility and duties. He would not recommend the amendment.

Member Corina Herrera-Loera said she spoke to Counsel Rogelio Ruiz before bringing this resolution and asked him about the Bond Committee if it should be added he said since it was voted on to bring it back to the Board.

Vice-President Ernesto Bejarano commented he spoke to Counsel Rogelio Ruiz and asked the same question.

9. Superintendent/ Board Business (continued)

Member Andrés Quintero said he agreed with Vice-President Ernesto Bejarano they cannot hold a band-aid and have the community wait around. He said the resolution presented by Corina Herrera-Loera is based on facts. Clerk Dolores Marquez-Frausto had the opportunity to defend herself to the FPPC and it resulted in a \$7000 settlement. He commented that basically, Clerk Dolores Marquez-Frausto admitted to it by signing a settlement. He said his concern is where did those \$5000 come from. He commented his colleague supported the Del Terra contract and he refused to participate.

Vice-President Ernesto Bejarano asked Counsel Peter Rehon if he feels what they are doing is logical or should they move on with it this evening.

Counsel Peter Rehon replied his recommendation is to what Member Corina Herrera-Loera noted to the calendar for the October 10th meeting. This will give the opportunity for Clerk Dolores Marquez-Frausto to respond in writing or appear before the Board and disclose questions and where the funds came from before the Board votes on the censure.

Member Andrés Quintero encouraged the Board to include the disclosure as to where did the funds come from.

Vice-President Ernesto Bejarano asked Counsel Peter Rehon assuming they did not get an answer from Clerk Dolores Marquez-Frausto at the October 10th meeting then how effective is the censure.

Counsel Peter Rehon replied the censure voted as proposed by Member Corina Herrera-Loera it is sufficient to protect the Board and to guide the Board in the future. The Board would need to take it on a case to case situation and the resolution would be inactive on October 10, 2019, framed by Member Corina Herrera-Loera this would not prejudice the problems and concerns in the future.

Vice-President Ernest Bejarano asked Counsel Peter Rehon if he could elaborate on his statement regarding the case by case situation.

Counsel Peter Rehon responded that clearly, the issue is the Board does not know where the funds came from and they are concerned about a potential conflict. He thinks it is fair to resolve those issues as they come up.

President Linda Chavez asked for Public Comments.

9. Superintendent/ Board Business (continued)

Public Comments:

- 1. Jocelyn Merz AREA President said she was going to read part of an email she sent to President Linda Chavez and Vice-President Ernesto Bejarano dated August 28, 2019, regarding this agenda item. She appreciates that there are being addressed. If Clerk Dolores Marquez-Frausto cannot account where the \$5000 came from how can she made decisions for the District with an annual budget of \$120,000,000 plus. Where is she going to substantiate where those funds came from. Can she substantiate that they did not come from a vendor that does business with the District which could be a potential conflict of interest.
- 2. Dilza Gonzalez thanked the Board for bringing this item to the public. She is worried about a Trustee that cannot manage \$5000 but is handling programs and money. She agrees that Clerk Dolores Marquez-Frausto should not be a part of the Bond Committee.
- 3. Flor De Leon thanked the Board for being transparent with this issue. Clerk Dolores Marquez-Frausto should not be part of the Bond Committee. There are schools that do not have air conditioning. She would like to invite the Board to a Community Forum on September 27, 2019, at 7:30 at FRC.
- 4. Ray Muller said he is highly concerned about having a person that has been here for a long time and has proven to have been doing things illegally. There is nothing she can say that she has not told FPPC. She has a tactic of missing meetings. He said they would be fighting on the issue of the contractor and she would miss month after month. He said Clerk Dolores Marquez-Frausto does not respect the people it would be nice to get this done. He said to the Board has the support of the community.

Member Corina Herrera-Loera asked Counsel Peter Rehon can the Board ask Clerk Dolores Marquez-Frausto to leave her sit and if he could the process if that could be done.

Counsel Peter Rehon replied as freedom of speech, yes you can ask Clerk Dolores Marquez-Frausto to do anything but you cannot direct her or remove her. That is part of the election process.

Vice-President Ernesto Bejarano asked what is the process to remove Clerk Dolores Marquez-Frausto from the Bond Committee.

Superintendent Bauer replied it is to her understanding the items can be moved by the majority and they can bring the item back to the body for amendment. She said Vice-President Ernesto Bejarano wants to know how to undo the Bond Committee.

9. Superintendent/ Board Business (continued)

Member Andrés Quintero said there was a previous Board member that attempted to use the parliamentary procedure to bring back an item again only the prevailing side can bring it back to the agenda.

Counsel Peter Rehon replied any item can be brought back to be agenized. He commented he is 80% certain.

Member Andrés Quintero said under the Robert Rules of Order you can bring the item back on the day of the meeting if you were on the prevailing side.

14.10 Resolution No. 07-19/20; Support for California Schools and Local Funding Act.

MOTION #04-02 by Member Andrés Quintero to approve Action Items 6.02 as presented. MOTION #04-02 was seconded by Member Corina Herrera-Loera.

Member Andrés Quintero said the reason he put in this resolution was in support of schools and the community. Schools and community first is an effort to equalize us. He is asking his colleagues to support this resolution forward.

President Linda Chavez said she is not supporting this because proposition 13 will mean higher taxes on businesses and homeowners. Families are leaving because the rent is high.

Vice-President Ernesto Bejarano asked President Linda Chavez what source did she get her information.

President Linda Chavez replied from the Howard Jar Tax Association. They first adopted proposition 13 in California. She said the state said the District is not spending their money right.

Member Andrés Quintero said proposition 13 does not target residential property nor business'. He said there are massive corporations that never change owners and pay the same taxes. Proposition 13 puts us in line with other states.

President Linda Chavez said she is a retired business owner and she got taxed for the inventory space she rented. Her concern is if you are a mom and pop business how this affects them. She will not be supporting this item.

Member Andrés Quintero wanted to clarify this is a new proposal and business owners are exempt.

President Linda Chavez commented the reason why it has been difficult for small businesses because they cannot afford California tax and the small businesses are moving to the south of Texas.

Member Corina Herrera-Loera said she is supporting this item because she believes it is fair.

Member Andrés Quintero commented if California is a horrible place why is it the 5th largest economy of the world and businesses are doing so well.

President Linda Chavez said in the past 10 years 75% of businesses have left. They open up their business and close in 5 years because they are not successful.

President Chavez asked if there is any public comment.

Public Comments:

- 1) Flor De Leon said proposition 13 is very important this will bring in \$11.5 billion dollars to the community and \$4.5 billion for education per year. She said salaries for teachers need to increase. The empuje parents support this proposition. This proposition is already in the ballot for 2020.
- 2) Alison Lingolani Chair from CBOC said the proposition 13 was from 1978 and the intent was to protect homeowners especially the elderly from losing their homes. The proposition will have everyone pay their fair share. This will protect small businesses and our children deserve this.
- 3) Camille Llanes-Fontanilla Executive Director from Somos said this proposition will restore \$11 million in services. She commented the rest of the money would go into health care and public safety.
- 4) Dilza Gonzalez commented she is concerned about people misinforming parents the rent will go higher. The policy says otherwise. She said they are losing small businesses it is not because of the tax rate there is a housing problem.
- 5) Rafael Zarate said he sent a recent email to the Board addressing his concerns regarding his concerns about the Community Liaison cuts. He told President Linda Chavez she had an interest in self-preservation instead of the interest of the community and schools. He formally petitioned to get the minutes where there were cutbacks of the Community Liaisons.

Superintendent Bauer commented this was a recurring item. She asked Member Andrés Quintero if there was something in particular needed.

Member Andrés Quintero replied no the public requested this item to be moved up.

Vice-President Ernesto Bejarano commented he has asked questions regarding this item. He said Superintendent Bauer has answered his questions. The Board approves the expenditures and it goes to the District from there to the County office.

Assistant Superintendent Chheng replied to Vice-President Ernesto Bejarano he was correct. He said it goes through the process for approval.

- 6) Brenda Zendejas said several parents are concerned about having a substitute teacher and they do not have the proper communication. She commented there is no bathroom for the kindergarten class that her son is in.

7.04 Alum Rock Educator's Association (AREA)

Jocelyn Merz said it was a bittersweet start with the tragic passing of Cynthia Mykkanen over the summer. She thanked the district for the monetary donation to Next Door Solutions in Cythina Mykkaen's name. She said AREA acknowledges the turmoil the district has been in. She commented that the district is asking the county for a waiver for the output of the teachers' salaries. She said they are grateful for the articles for the bargaining tentative agreement. She thanked whoever planned out the Back to School BBQ.

6.05 Superintendent

Superintendent Bauer said she appreciated AREA President Jocelyn Merz's remarks. She commented it has been very difficult at the beginning of the school year. She wished she had a magic wand and fix everything. She thanked everyone at Alum Rock School District.

Vice-President Ernesto Bejarano said there had been many challenges and they have made a lot of progress. He commented to expose students to other career paths. He mentioned to staff to follow up with Voler regarding the terms of the deliverables and to discuss an opportunity to do more for the district. He thanked Senior Executive Assistant Maribel Carrillo for setting up computers for the Board Meeting in order for him and the Board members to access Board Docs. He also acknowleged her hard work.

Member Corina Herrera-Loera said she remembers a year ago sitting in the audience and she knows there are many areas of growth as a new leader. She said as a leader she will continue to do her best. She commented that she spent many hours on the resolution she brought forth today. She said this type of behavior cannot be allowed in their district. She looks forward to seeing everyone at meetings.

Member Andrés Quintero said he shared many of his concerns with a lot of folks. He said he trusts that the staff has been doing a good job. He commented there were mistakes made in the past and he is glad that they moved ahead. The people who sign up to be on the Board need to do a good job. He thanked Superintendent Bauer for the great job she is doing and for bringing back credibility to the district.

President Linda Chavez thanked everyone for being at the Board meeting. She said there has been training for the Board. She commented she respected the staff because they are doing a great job. She said she is learning every day and said being a Board member is not easy.

President Linda Chavez replied it was for the Board.

MOTION #04-06 by Member Andrés Quintero provide \$100 to Trustee Chavez's professional development fund in addition to her current professional development fund to get the training she needs. MOTION #04-06 was seconded by Vice-President Ernesto Bejarano.

10. Instructional Services

10.01 2019 California Assessment of Student Performance and Progress (CAASPP) and English Language Proficiency Assessments for California (ELPAC).

Presentation from Ms. Britany Rykels Coordinator from Academic Services. Some of the highlights included the following:

- ELPAC four areas: reading, writing, and listening.
- Scores by the school- a total of each site
- Language Proficiency
- ELA second language
- ELPAC testing
- Homeless students 131 and 36 foster students
- California Dashboard ELA & Math
- 83% of Social Economic Students

Superintendent Bauer said for the past four years there has been a reduction of English learners.

Vice-President Ernesto Bejarano asked if the foster students in their own subgroup.

Coordinator Ms. Brittany Rykels replied that they do not have their own subgroup for the dashboard.
