

You are currently enrolled in Spring Semester 2020 Driver Education ...

We are preparing to start the permitting process for Spring Driver Education students!!!
Completing the process allows enrolled students:

- to start the probationary 9 month permit period earlier
- to practice at home with parent before 2nd semester to build confidence and skill level in the car
- to be license eligible as early as August of 2020 provided all classroom and driving requirements are met.

STEP 1- During the week of October 15-18th, STUDENTS come to room **6086!**

- **Before school (7:30-8:30) OR during 1, 2, 3, 4, 5 or 8th period IF you have free.** (*This process will take about 5 minutes.*)
- **Take an Eye Exam.**
 - Bring or wear contacts/glasses. **Make sure prescription is up to date.** We will be testing for 20/40 vision requirements set by Secretary of State.
 - Night correction contacts are not a requirement.
- Pick up Rules of the Road booklet.
- Fill out a short form.

STEP 2- Parent Information Meeting/Student Permit Application & Test
On October 22nd @ 7 pm

Parents will meet in the Recital Hall (right of the PAC) for an informational meeting.

- Information about permits, laws, requirements, and question session.

Students will meet in the Little Theater (left of the PAC):

- iPad required to fill out an online application and take Rules of the Road test.
 - Bring IPAD and form given during eye test!!!
 - Rules of the Road test is a 40 questions multiple choice test.
 - Must get 32/40 to pass. *Students who do not pass will have 2 other opportunities to take at a later date.*
 - *Students who are unable to attend will have opportunity to take at a later date. We will contact all students the week after October 22nd. Parents are NOT required to attend on alternative date.*

STEP 3- Applications will be given out the following day, October 23rd. STUDENTS need to pickup application in room 6086!

- Come BEFORE school OR during 1, 2, 3, 4, 5th OR 8th hour.

- Application needs to be signed AND returned to the DE office with \$20, cash or check (*written out to: Illinois Secretary of State*).
- Students need to return signed application and Permit fee by November 5, 2019 @ 2:30, permit applications received after November 5th will be taken for processing at a later date.
- Permits should be ready the week of Thanksgiving for pickup, students will receive email when permit is available.

******Please note IF you drop the course before fall, their permit will be CANCELLED! Students MUST be enrolled in the course to get your permit!***

- October 22nd- Parent Informational meeting and Student Permitting at 7pm
- October 23rd- Pick up application from 6086, returned parent/guardian signature and \$20.
- November 5th: Application and money due.
