

## Extended Day Program Information & Contract 2019 – 2020

Green Acres offers its families an Extended Day Program (EDP) from the end of the school day until 6 PM. Expanded Care (EC) is also available from 8 AM–5 PM on select days when school is closed for conferences or professional development. The program does not operate when inclement weather requires school cancellation or early dismissal. EDP offers yearly contracts for 1, 2, 3, 4, or 5 days per week. The goals of the Extended Day Program are: a safe environment for children after school; an opportunity for children to interact, play, and develop relationships across age groups; mandatory homework time for 3<sup>rd</sup> - 8<sup>th</sup> grades; and a generous snack.

<u>EDP Drop-in Policy</u> - Children may attend EDP on a drop-in basis provided space is available. Arrangements must be made at least 24 hours in advance by submitting a Transportation Change through the parent portal at greenacres.org.

<u>EDP Drop-in Fees</u> - A single drop-in fee is \$36 per child, per day. A child participating in an after-school activity may join EDP on that day at a discounted rate of \$18 per child. The hours for this discount are from 4:30–6 PM. Arrangements must be made at least 24 hours in advance by submitting a Transportation Change through the parent portal at greenacres.org.

Sign-Out Procedures - Every child must be signed out by an adult authorized to pick him or her up. The adult MUST sign the Extended Day Attendance Sign-Out sheet located in the library. If your child will be picked up by an individual whose name has not been previously authorized on your child's emergency form, you must provide this individual's name in the note section of the Transportation Change through the parent portal at greenacres.org.

<u>Late Pick-Up Policy and Fees</u> - Children may be picked up any time before, but no later than, 6 PM. Extended Day closes promptly at 6 PM. A late charge of \$10 per child is due after 6:05 PM by the School's telephone clock, with an additional \$1 charge for each minute after 6:05 PM. Notification by parent of late pickup will not eliminate a late pickup charge.

<u>Expanded Care (EC)</u> - Snacks are provided. Hot Lunches are not served on Expanded Care days. Please pack a lunch for your child. See chart below for pricing information. See EC calendar dates in *GreenLine* and on website under calendar.

<u>Contract Types</u> - Contracts are available for 1, 2, 3, 4, or 5 days a week. For children who have contracts for 1–4 days, families select the days when their children are expected in EDP. Selected days may be exchanged within a given week by submitting a Transportation Change through the parent portal at greenacres.org **at least** 24 hours in advance. If students attend more than their contracted days within a given week, those additional days will be charged a drop-in rate.

<u>Contract/Payment Information</u> - A non-refundable application fee of \$30 and a deposit of \$300 per child must accompany a completed application/contract to hold a space in the program. Please complete the contract with a check for \$330 per child and return it to the front office by Friday, April 19, 2019. EDP contract charges are billed on student tuition bills. The \$300 deposit is non-refundable after July 31, 2019. Contracts received after April 19, 2019 will be processed on a space available basis. Enrollment priority will be given to children enrolled full-time (5 days per week).
