HIGHLIGHTS FROM THE OCTOBER 2019 BOARD MEETINGS

Student Council Report: Peyton Celesti, Student Council Representative, provided a Student Council update. He reported on expanding school spirit activities to monthly events. Peyton also mentioned a recent Pep Rally, and homecoming.

Beattie Student Report: Olivia Soost, Beattie Student Representative, provided a Beattie update. She mentioned that there were four award categories for the recent Challenge Award. She mentioned there will be a Leadership Conference in Seven Springs in November. Olivia also talked about recent activities of the cosmetology students, including a recent fundraiser.

- Approved Dr. Chris Caton to deliver a presentation at the China Education Innovation Expo hosted by Beijing Normal University in Zhuhai, China from November 20 - 22, 2019. This comes at no cost to the district.
