I. Call to Order: 5:35 pm

II. Policies for Review and Discussion:

- 1. <u>Regulation #5139 Participation Fees for School Activities</u>: Subcommittee members reviewed a draft regulation related to participation fees for school activities, which are limited to high school sports for the 2019-2020 school year. Mr. Hoff explained the regulation and subcommittee members asked questions related to the regulation, how it will be enforced, and who is responsible for enforcing it. After discussion, the subcommittee recommended that the district also incorporate language pertaining to Pay to Park into the same regulation. District leaders will now make final adjustments to the regulation prior to distributing it to families and placing it on the district website. The regulation does not need approval from the full Board of Education.
- 2. **Bylaw #9325 Meeting Conduct**: Subcommittee members discussed updating this bylaw to add language for a second public comment period at the end of Board meetings and also to add a meeting end time. Other language in the bylaw is also being updated, such as language related to meeting disruptions and complaints concerning district personnel. The bylaw is being forwarded to the full Board for consideration on 30-Day Read.
- 3. <u>Bylaw #9325.2 Order of Business</u>: Subcommittee members discussed updating this bylaw to add language for a second public comment period as well as Board member comment following both public comment periods. The bylaw also adds a Board of Selectman Liaison Report and a Board of Finance Liaison Report, as well as Board Liaison Reports for various committees that Board members serve on. The bylaw is being forwarded to the full Board for consideration on 30-Day Read.
- 4. <u>Bylaw #9271 Code of Ethics</u>: Subcommittee members discussed updating this bylaw to incorporate language consistent with the current recommended version from the Connecticut Association of Boards of Education. The bylaw is being forwarded to the full Board for consideration on 30-Day Read.
- III. Review and Prioritization of Policy Updates: The subcommittee discussed policies and bylaws to prepare for its next meeting, which include #5145.511 Sexual Abuse Prevention Education Program; #6171.2 Preschool Students with Disabilities; #6172 Alternate Education Programs; #5144.4 Physical Exercise and Discipline of Students; #9230 New Board Member Orientation; and a possible change in language for an Athletic Policy.
