# **PROOF OF CHILD'S AGE**

### Certified Birth Certificate Or Record of Baptism

Passport

Where a certified transcript of a birth certificate or record of baptism (including a certified transcript of a foreign birth certificate or record of baptism) giving the date of birth is available, no other form of evidence may be used to determine a child's age.

If a certified birth certificate, record of baptism or passport, is not available, the District may consider other documents as proof of a child's age. Please contact the Central Registration Office to inquire about what may be acceptable.

## EVIDENCE OF PARENTAL CUSTODY (IF APPLICABLE) – ACCEPTABLE DOCUMENTS

OR

**Court Ordered Custody/Guardianship** — If a court has issued an order pertaining to the custody or guardianship of a child, the court papers must be presented at the time of registration, along with photo identification for the custodian(s)/guardian(s).

**Statements of Custody:** If a child is living with persons within the District other than the child's biological or adoptive parents, and no court order has been issued awarding custody or guardianship to the person(s) with whom the child is living, the District requires the parent(s) and person(s) in parental relation to provide statements verifying the transfer of parental custody and control.

Federally Approved Sponsor(s): The District also may accept other proof of parental custody and control, such as documentation indicating that a child resides with a sponsor with whom the child has been placed by a federal agency.
