INFORMATION ITEMS

2017 CAASPP

Joy C. Gabler, Superintendent, presented for information a power point presentation on the results from the 2017 California Assessment of Student Performance and Progress (CAASPP). The results focused on met and exceeded percentages for the purpose of reporting to the Board on our progress as a district. She informed the Board that the California School Dashboard, which will provide our results in the new accountability model, will be available in November.

Trustee Garner asked if the district is still using benchmark testing to monitor student progress throughout the year. Superintendent Gabler answered the district has been using the interim assessments provided by the Smarter Balanced Assessment Consortium (SBAC) – the developers of the state assessment. Superintendent Gabler added that the district is looking to develop benchmarks since the interim assessments have not provided the information needed to monitor student progress. Although she added, that some recent improvements to the interims may provide us with the information we need.

Trustee Strickland asked if it's based on Common Core. Superintendent Gabler answered yes.

Trustee Garner asked how is it scored. Superintendent Gabler answered the test has multiple choice and written responses. The multiple choice items are scored by computer and the written responses are scored by teams of scorers. HESD staff has attended training on the scoring process.

Trustee Strickland asked if the data is incorporated with LCAP. Doug Carlton answered it is required. Superintendent Gabler added that the data used for LCAP will be pulled from the California School Dashboard and the new accountability model based on the 5-by-5 color coded grid.
