## **Fee Schedule**

The fee for full time participation in the bus program for both one way and round-trip transportation is nonrefundable. A \$200.00 per rider deposit is due with the contract. The remaining balance is billed by semester, in September and December. The deposit is applied to the December billing.

For families with multiple full time, round trip riders, there is a multiple rider discount of \$50 for the second child and each additional child thereafter.

Adjustments will not be made to transportation charges for students participating in any athletic games, practices, or special events.

## **Bus Transportation Contract**

The bus transportation contract follows. Contracts are accepted on a first-come, first-served basis, with current students and siblings given priority, until May 31, 2019. Notification of service will be confirmed by July 1, 2019.

## **Bus Transportation Contract**

We, the undersigned parents, guardians or legal representatives hereby request that St. Johns Country Day School allow our child(ren) to participate in the transportation program for the 2019-2020 School year. The undersigned parents, guardians or legal representatives hereby consent to the participation of their child(ren) named above in the transportation program.

St. Johns Country Day School will provide transportation on School days between August 13, 2019 - May 22, 2020 to/from the designated pick-up site and St. Johns Country Day School.

All rules, policies, and procedures outlined in the current Student Handbook are in effect for students during their participation in the transportation program. All infractions, in addition to any possible consequences outlined in the handbook, will be referred to the Dean of Students or Division Head, who has the right to dismiss a student from the program. If a student is dismissed from the program, there are no refunds.

Transportation will be provided by St. Johns Country Day School. To request that your child(ren) participate, please read, complete, sign and return this contract which includes your consent, as well as a full release of liability. As parent or legal guardian, you remain fully responsible for any acts of the named student(s).

For and in consideration of the student(s) being allowed to participate in this program, and other valuable consideration, the undersigned parents, guardians or legal representatives, on behalf of the student(s) and the student's parents, personal representatives, assigns, heirs, and next of kin, do hereby release and hold harmless St. Johns Country Day School, its employees and agents of said parties engaged in this particular program, and their personal representatives or assigns, from any loss or damage on account of any injury to the person or the personal property, of the student(s), or death, caused by negligence or otherwise, while the student(s) are engaged in the bus transportation program. The undersigned expressly agree that this release, waiver and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Florida, and that if any portion of this agreement is held invalid, it is agreed that the balance shall notwithstanding, continue in full legal force and effect.

The undersigned parents, guardians, legal representatives further acknowledge that they are authorized to enter this agreement on behalf of the student(s), and the student's parents, personal representatives, assigns, heirs, and next of kin.

Note: Adjustments will not be made to transportation charges for students participating in any athletic games, practices and special events.

We, the undersigned, agree to all terms and conditions of this contract and to comply with all current policies, rules, and regulations of St. Johns Country Day School and any amendments or changes made to said policies, rules, and regulations.

We agree to pick up our student(s) at the designated time. Failure to do so may result in dismissal from the program.
