<p>Program Overview:</p>	<p>Pathways in Technology Early College High Schools (P-TECH) is an open-enrollment program that provides students with work-based education. As part of the Accounting program, students take courses that provide the academic, technical, and workplace skills that are attractive to employers. Students have the potential to earn an associate’s degree in four years, along with industry certificates for their selected career pathway. These opportunities can potentially lead to paid internships and job placement after graduation. Students have the opportunity to earn up to 60 hours of tuition-free college credit while pursuing their high school diploma.</p>

<p>Program Objectives & Certifications:</p>	<ul style="list-style-type: none"> • The <u>Accounting Clerk Certificate</u> emphasizes development of basic accounting, spreadsheet, word processing and ten-key skills. Courses are applicable to the Accounting Assistant Certificate and the Associate in Applied Sciences Degree in Accounting. It can be completed in one semester. • The <u>Accounting Assistant Certificate</u> is designed to provide expanded knowledge of basic principles while emphasizing communication and human relations skills necessary for career advancement. Courses are applicable to the Associate in Applied Sciences Degree in Accounting. It can be completed in two semesters. • The <u>Accounting Associate in Applied Sciences Degree</u> provides preparation for various career opportunities in accounting, with specializations that include financial, managerial, cost, tax, and/or small business accounting. It can be completed in two years if you are a full-time student.
