Grant Timeline and Budget Overview

The Strengthening Career and Technical Education for the 21st Century Act (Public Law 115-224) was signed into law on July 31, 2018 and reauthorized the Carl D. Perkins Career and Technical Education Act of 2006. In accordance with the transition provisions in Section 4 of the Act, the 2019-20 program year will be the transition year between Perkins IV and Perkins V, where the state and eligible school districts will spend the year planning and preparing to fully implement the new Perkins V requirements during the 2020-21 program year.

Purpose: Federal regulations (34 CFR 76.708) require that federal formula grant funds may not be obligated (incur costs) until the latter of the following two dates: (1) July 1 or (2) the date the applicant submits its application to the State in substantially approvable form. Federal regulations further stipulate that reimbursement for obligations is subject to final approval of the application.

Of the funds subawarded as an eligible subrecipient, 20% is available for obligation on July 1, 2019; the remaining amount is available October 1, 2019, pending an updated Grant Award Notice (GAN) from the US Department of Education. All funds expended under this award must be obligated by August 31, 2020

The Office of Superintendent of Public Instruction (OSPI) will review the application and communicate to the district if further action is necessary or if full approval has been issued. The application must be completed and approved prior to the release of funds.

The recipient is required to complete a **Comprehensive Local Needs Assessment (CLNA)** during the 2019-20 school year. This CLNA will be required for allocation of 2020-21 Perkins V funds. Further guidance will be provided by OSPI on the format of the CLNA.

It is important to note that this data-driven approach means that the results from each eligible recipient's CLNA will dictate the types of programs and activities that agencies can implement with Perkins V funds during the 2020-21 program year and in subsequent program years.

Transition Activities for School Districts during the 2019-20 Program Year

Although Perkins V builds on Perkins IV, there are a number of notable changes in the new Act. Several of these are particularly important for School Districts during the 2019-20 transition year, including:

- Focus on data-driven local planning and spending of Perkins funds by requiring a Comprehensive Local Needs Assessment (CLNA). The initial CLNA must be conducted by local school districts during this transition year.
- Greater emphasis on stakeholder engagement. Perkins V requires significant consultation with a required group of stakeholders, at both the state and local levels, not only while conducting the CLNA but also in development of the local application and in ongoing program planning, implementation, evaluation, and required needs assessment updates.
- Increased focus on serving special populations and on closing gaps in performance and enrollment between these and other student groups, which is why the assessment of the current situation of subpopulations is required in the CLNA. The District will be developing grades 9- 12 a seminar course that will provide students college and career activities that will complement not only Highlines advisory but the established CTE programs. A percentage of the Perkins funds are used to subscribe to Naviance in all of the CTE middle and high schools in the district, which will allow CTE teachers and College and Career access specialist to understand students' career aspirations and help them plan for rigorous course-work before they graduate. The course planning tool with Naviance assists students in understanding the courses they need take to graduate and move on to the next level. The use of the College Majors section of Naviance and linking it to the students high school course work helps them to see the connection.

The district is working with school sites and program areas to develop a focused career pathway for all CTE students to include a sequence of courses that culminates in a "college/career like" experience of AP, IB, Running Start, Dual Credit (Tech Prep), or a strong apprenticeship-like course aligned with a students program of study.

Highline School District has a comprehensive professional development program that supports CTE Teachers and staff in obtaining professional development at both the district, state, and national level. CTE teachers meet bimonthly for professional development to integrate core academic standards into their curriculum, devise assessments based on the academic and industry standards that measure student growth, develop work-integrated experiences for their students, and further expand the rigor and relevance in their curriculum. Career guidance, academic counselor, paraprofessionals and CTE instructors attend yearly training based on college and career readiness activities.

CTE teachers and support staff are supported in professional growth through participation in

opportunities to attend professional conferences such as: WA-ACTE, CTE Area Groups, Applied Math training, ACTE, Project Lead the Way training, Code.org training, various STEM professional development and any other related activities to career and technical education etc. This will provide teachers, faculty, school leaders, administrators, specialized instructional support personnel, career guidance and academic counselors, or paraprofessionals, as appropriate, with opportunities to advance knowledge, skills, and understanding of all aspects of an industry, including the latest workplace equipment, technologies, standards, and credentials. As well as to provide training to appropriate accommodations for individuals with disabilities, and students with disabilities who are provided accommodations under the Rehabilitation Act of 1973 (29 U.S.C. 701 et seq.) or the Individuals with Disabilities Education Act;

Please describe how the district will meet the requirement:

Each high school or small school site has a College and Career Specialist to provide support for career guidance and academic counseling, as well as a strong advisory program, and counselors who support career exploration and planning. Through classroom presentations, speakers, field trips, and the use of Naviance, these adults will assist students in decision making regarding post-secondary training options and preparation for high skill, high wage, and high demand jobs. The goal is for students to gain an understanding of the industry as a whole and the many roles an individual can play.

We plan to continue investing heavily in growing our advisory boards. Last year we did a major outreach to our business and industry community building a strong network of professionals who are committed to providing expertise and assistance to our students and programs through serving on advisory boards, providing advice on curriculum and equipment, conducting classroom presentations, hosting job shadows, and internships. Through coordinating with our professional career partners, and the assistance of our work based / worksite learning manager, we have set the goal of providing all our students with a real-world work experience before they graduate.

We continue to support CTSOs at all of our campuses and ensure those organizations are funded to meet regularly and take field trips to relevant businesses and community experiences. We will also promote the work of career specialists and work-based learning coordinators in order to encourage more teachers, counselors, and administrators to support the roles of finding industry connections for students.

These academic learning standards are Arts, Computer Science, Educational Tech, English Language Arts, Environment & Sustainability, Financial Education, Mathematics, Science and Social Studies. This will also include 21st Century Skills.

The resources needed to effectively conduct the CLNA will be, expenditures to staff outside consultants, staffing stipends and staffing FTE allocation, travel expenses for professional development, conferences and meetings, facility usages fees. Purchase of Equipment, supplies, software and subscription licenses.

The CLNA leadership and stakeholders teams will collaborate on defining the data that is need to be collected by first quarter pending the release of the Perkins V CLNA Washington Template from the Community and Technical Colleges Washington State Board, Washington Superintendent of Public Instruction and the Washington State Training & Education Coordinating Board.

The leadership team by second quarter will establish a draft data sets to be reviewed by the team for third quarter. The data sets shall be revised and edited and completed by third quarter. The final data sharing to be viewed to all stakeholders by the end of 4th quarter.

The collected data will identify occupations where new program offerings may be needed to be funded or not funded in our region, particularly those that are high demand, high growth and high wage. This will also help identify those areas which are under represented occupations that have not been well surveyed in the data collections this could represent self-employment, emerging new occupations, the arts and agriculture as an example. This data will also help in identifying occupations without strong labor market demand or wages for which we may currently be offering as programs this may be identified as low wage, low or negative year to year openings, low growth annually / multi-year. A review of this list may lead to the funding

consideration whether this program offering should be phased out or not offered as a CTE course.

The results of the CLNA will be used to prepare the local application and budget beginning with the 2020-21 school year.

Programs of Study / CTE Dual Credit

New federal definition of a Program of Study: The term “Program of Study” means a coordinated, non-duplicative sequence of academic and technical content at the secondary and postsecondary level that:

- A. Incorporates challenging state academic standards including those adopted by a state under section 1111(b)(1) of the Elementary and Secondary Education Act of 1965;
- B. Addresses both academic and technical knowledge and skills including employability skills;
- C. Is aligned with the needs of industries in the economy of the state, region, tribal community or local area;
- D. Progresses in specificity (beginning with all aspects of an industry or career cluster and leading to a more occupation-specific instruction;
- E. Has multiple entry and exit points that incorporate credentialing; and
- F. Culminates in the attainment of a recognized postsecondary credential.

Programs of Study

The following are minimum criteria for program of study assurances:

- The secondary CTE, academic, and appropriate elective courses are included, as well as the state and local graduation requirements.

- The secondary Program of Study includes leadership standards, through 21st Century skills.
- The Program of Study includes coherent and rigorous coursework in a non-duplicative sequence of courses from secondary to postsecondary.
- Completion of the secondary Program of Study prepares students for entry into the postsecondary opportunities (military, employment, apprenticeship, certificate and/or degree programs).
- Program of Study courses include appropriate state standards and/or industry skills standards.
- Program of Study leads to an industry recognized credential; academic certificate or degree; or employment.

The Highline CTE Program, in collaboration with industry and college partners, will establish a program of study to provide a detailed guide for students and their parents/guardians with a clear understanding of the established six course pathways. These pathways to Agriculture Food & Natural Resources, STEM, Health Sciences, Family & Consumer Sciences, Skilled & Technical Services, and Business & Marketing are designed to connect CTE classes to a registered apprenticeship, industry certifications and two- and four-year college and military.

The Highline CTE program, in collaboration with Renton Tech, Green River College and Highline College, has developed articulation agreements to enable HPS students to receive high school and college credit through CTE programs offered in HPS. In developing further connections with additional universities, colleges, technical and trade schools through the Puget Sound Dual Credit Careers Connection, WDC and Career and trade partners will expand class offerings in a secondary school to HPS students.
