Meeting Called to Order

The meeting was called to order at 6:00 p.m. at the Middle School by President Grimm.

Executive Session

Upon a motion made by Mrs. Kesel, seconded Mrs. Pedzich, with all present voting yes, the Board of Education approved calling an Executive Session at 6:00 p.m. for the purposes of one discussion regarding proposed, pending or current litigation.

Meeting Called to Order and Pledge of Allegiance to the Flag

Mrs. Grimm reconvened the meeting at 6:33 p.m. and asked everyone to stand for the Pledge of Allegiance.

President's Comments

Mrs. Grimm welcomed all in attendance.

Superintendent's Overview

Superintendent Erdle stated that the Board would first hear from Mr. Andrew Thomas, Community Relations Coordinator, with the results of the Budget Survey that was conducted February 15 through March 1, 2013 by K-12 Insight. Then Mrs. Carleen Pierce, Assistant Superintendent for Business, will present a presentation on Revenues. Following both presentations the audience members will break up into small groups and meet with a Board member and Administrator to answer the question of "What are revenue sources the District should investigate?"

Survey Analysis

Mr. Thomas noted that there were 872 completed responses for the budget survey; a 24.23 response rate. This is lower than last year's survey response rate of 36%, but still high for a survey of this type. The breakdown was parents-467; support staff-192; teachers-170; and website-43.

Overall, the survey respondents:

- Feel they understand the Tax Cap law 86.7%
- State that Canandaigua's tax increase has been driven mostly by cuts in state/federal aid 81.5%
- Confirm direct relationship between values of their home and quality of school district 73.5%
- Support a local tax levy in excess of the cap to MAINTAIN current program 56.4%
- Value all programs, but
 - voted Technology Education; Counseling/Guidance; Low Class Size at K-5; and Art & Music and Electives in Core Subject Areas are MOST important to protect
 - voted Technology Equipment for the Classroom, K-8 Enrichment, and Library Media program LEAST important to protect
 - o value Social Emotional Support Programs for Students & Athletics
 - o would consider cuts in Field trips and After School Recreational/Social Clubs

Most frequent similar comments included:

Alternative sources of revenue

- Corporate/Business Development/sponsorship efforts/naming rights/partnerships 17
- Pursue County to raise sales tax by .5% and share revenue to schools 16
- Don't raise sales tax 2
- Form special sub-committee (board members, community, businesspeople) to investigate alternate revenue sources – 9
- Charge nominal attendance fees for everything (plays, games, etc.) 9

Employee Benefits

• Reduce/Cut Employee Benefits - 14

Local Taxes

Do not raise my local taxes – 16

Shared Services

- Implement Shared Services (including BOCES) but sensibly, not for political purpose 14 Participation Fees
- Participation fees for participants in extracurriculars/sports 13

Waste Elimination

- School bus run efficiency 7
- Too much expensive technology, especially at lower grades 4
- Enforce walking protocols/expand radius 4

Out of District Tuition

- Examine charging some tuition for students of out-of-district employees 7
- Offer tuition-based option for out-of-district students (enough to cover costs) 5

Volunteers

- Utilize more volunteers (parents, VA vets, etc.) for class prep/supervision/school monitors 6
 <u>Fairness</u>
- Necessary to exercise fairness in budget cutting; cut across board 6

It was reiterated that this survey is completed by an outside firm allowing complete anonymity to those completing.

Revenue Overview

Mrs. Carleen Pierce began by providing an overview:

- Over 76% of State Aid is frozen
- Transportation Aid continues to be overstated
- Building Aid does not include the mandatory adjustment for re-calibration
- BOCES Aid continues to decline
- Over last four years the District has lost over \$15MM in State Aid due to Gap Elimination Adjustment

Mrs. Pierce presented the adjusted Governor's aid run for 2012-2013 of \$21,428,779 versus the actual of 21,439,747. This represents an increase of only \$10,968. She reviewed the proposed usage of Reserve Fund for the 2013-2014 school year, which would be at the same level as the 2012-2013 school year at \$1.3M. Her presentation also included a review of the Wayne Finger Lakes and many Monroe county school districts similar to Canandaigua City School District and their tax rate per thousand since 2008. Canandaigua has consistently been 11th from the bottom, out of approximately 48 schools. Currently, the forecasted tax rate is \$19.34 per \$1,000 but may change as further information is received.

Adjournment

Upon a motion made by Mr. Delforte, seconded by Mrs. Thomas, with all present voting yes, the Board of Education approved the adjournment of the Regular meeting at 7:25 p.m. to breakout meetings for those in attendance to provide suggestions for potential revenue sources. The next Regular meeting will be on March 14, 2013 at the Operations Center at 6:30 p.m.
